Damages; providing penalties for damaging or tampering with vehicles or implements of husbandry. Effective date.
2. **SB 1332 By Schulz et al of the Senate and DeWitt of the House**
Driver licenses; authorizing a test to be taken on the Internet; providing for a certain Emergency.
3. **SB 1364 By Griffin of the Senate and Sanders of the House (Proposed Comm. Sub., req. #3234)**
Zone of safety; modifying what a park is; prohibiting certain persons convicted of certain crimes from entering or loitering within 500 feet of a park. Effective date.
4. **SB 1369 By Schulz et al of the Senate (Proposed Comm. Sub., req. #3255)**
Motor vehicles; modifying gross vehicle weight limits. Effective date. Emergency.
5. **SB 1431 By Newberry of the Senate and Peterson of the House**
Sex Offenders Registration Act; adding certain persons and crime to which the act applies. Effective date.
6. **SB 1433 By Newberry of the Senate and Peterson of the House**
Human trafficking; modifying required service of minimum percentage of sentence; definitions; penalties. Effective date.

7. **SB 1443 By Holt of the Senate and Echols of the House**
Sex Offenders Registration Act; modifying to whom the Act shall not apply under certain circumstances. Effective date.
8. **SB 1474 By Paddack of the Senate**
The Council on Law Enforcement Education and Training; providing for an Executive Director; powers and duties; background investigations; reports; fine; disciplinary action; notice. Effective date.
9. **SB 1539 By Crain of the Senate**
Human trafficking; adding definition; establishing certain percentage of service of certain sentence; providing for certain terms of imprisonment, exception and certain level of behavior. Effective date.
10. **SB 1542 By Crain of the Senate**
Sex Offenders Registration Act; adding certain persons and crime to which the act applies. Effective date.
11. **SB 1720 By Brecheen of the Senate and Hickman of the House**
Probation-parole officers; requiring probation supervision to meet certain minimum standards; setting certain requirements for supervision agencies. Effective date.
12. **SB 2071 By Sykes of the Senate and McBride of the House**
Unlawful removal of objects; making it unlawful to take or remove certain objects from a disaster area; penalty. Effective date.
13. **SB 2079 By Dahm of the Senate and Echols of the House**
Firearms; modifying definition of a pistol. Effective date.
14. **SB 2084 By Burrage of the Senate and Sherrer of the House**
Wrecker or towing services; modifying on what a certain assessment shall be predicated. Effective date.
15. **SB 2114 By Dahm of the Senate and Roberts (Sean) of the House**
Oklahoma Self-Defense Act; making the cite fit the Act. Effective date.
