Privilege tax; limiting time period during which tax credits may be claimed by banking associations and credit unions. Effective date.
8. **SB 1245 By Mazzei of the Senate and Sears of the House**
Public finance; requiring certain proposed agreements to be reviewed by State Bond Advisor. Emergency.

9. **SB 1246 By Loveless et al of the Senate(Proposed Comm. Sub., req. #3389)**
Income tax; modifying tax rate for specified time periods; requiring Board of Equalization to make determination. Emergency.
10. **SB 1341 By Mazzei of the Senate and Sears of the House (Proposed Comm. Sub., req. #3303)**
Income tax; limiting time period during which certain tax credits are allowed; limiting amount allowed per taxpayer for certain time period. Effective date.
11. **SB 1621 By Simpson of the Senate and Ownbey of the House**
Income tax; modifying amount of deduction for expenses related to foster care. Emergency.
12. **SB 1629 By Bingman of the Senate and Sears of the House (Proposed Comm. Sub., req. #3336)**
Uniform tax procedure; deleting obsolete language relating to interest rate on delinquent refunds. Effective date.
13. **SB 1631 By Boggs of the Senate and DeWitt of the House**
Public finance; construing requirements regarding electronic payments; authorizing taxpayer election related to tax refund. Effective date.
14. **SB 1639 By Bingman et al of the Senate (Proposed Comm. Sub., req. #3373)**
State government; Governor's Council for Workforce and Economic Development; updating statutory language. Emergency.
15. **SB 1711 By Standridge et al of the Senate (Proposed Comm. Sub., req. #3331)**
Income tax; clarifying time period during which certain credits may be claimed. Effective date.
16. **SB 1869 By Anderson et al of the Senate**
Public finance; specifying information to be included in Bond Advisor report. Effective date
17. **SB 1892 By Johnson (Rob) et al of the Senate (Proposed Comm. Sub., req. #3387)**
Revenue and taxation; modifying tobacco products tax relating to tobacco-derived products; modifying procedures. Emergency.
18. **SB 2007 By Shortey et al of the Senate (Proposed Comm. Sub., req. #3364)**
Oklahoma Charity Games Act; providing exemption from specified tax for certain healthcare organizations. Effective date.
19. **SB 2011 By Shortey of the Senate (Proposed Comm. Sub., req. #3360) Franchise tax;**
limiting time period during which franchise tax is levied. Effective date.
