Collective bargaining; prohibiting collective bargaining agreements for certain police officer terminations. Effective date.
3. **SB 258 By Holt of the Senate (Proposed Comm. Sub., req. #1430)**
Creating the Small Business Deregulation Task Force; providing for membership, duration, staff and chair.
4. **SB 370 By Halligan of the Senate and Denney of the House (Proposed Comm. Sub., req. #1384)**
Accounting; providing exception for succession of business by sale or transfer; requiring certain notice. Effective date.
5. **SB 383 By Bice of the Senate**
Intoxicating liquor; retail package store license authority; allowing chilled beer. Effective date.
6. **SB 392 By Newberry of the Senate and Cooksey of the House**
Oklahoma Real Estate Code; licenses; adding exception. Effective date.

7. **SB 425 By Holt of the Senate (Proposed Comm. Sub., req. #1495)**
Intoxicating liquors; modifying types of licenses; adding public cater endorsement; specifying fee. Effective date.
8. **SB 432 By Floyd of the Senate (Proposed Comm. Sub., req. #1385)**
Labor; enforcement; increasing penalties. Effective date. Emergency.
9. **SB 451 By Brinkley of the Senate**
Used Motor Vehicles; modifying certain exception; adding certain dealer to requirement to provide certificate of title. Effective date.
10. **SB 583 By Shortey of the Senate**
Professions and occupations and trades; prohibiting membership as condition for licensure. Effective date. Emergency.
11. **SB 592 By Anderson of the Senate**
Oklahoma Used Motor Vehicle and parts Commission; license term; deleting BID cards; increasing fees. Effective date.
12. **SB 688 By Jolley of the Senate and ODonnell of the House (Proposed Comm. Sub., req. #1482)**
Low-point beer; manufacturer; termination agreements; unreasonable withholding of consent to transfer. Effective date.
13. **SB 690 By Jolley of the Senate and Echols of the House (Proposed Comm. Sub., req. #1359)**
Intoxicating liquors; brewer; distribution agreements; terms, definitions, successor business. Effective date. Emergency.
14. **SB 710 By Sparks of the Senate**
Employee information; allowing a public school to disclose certain employee information. Effective date. Emergency.
