Income tax; modifying provisions related to credit for zero-emission facilities; providing contingency related to expiration date. Effective date.
9. **SB 502 By Quinn et al of the Senate and Sears of the House**
Income tax; prohibiting allowance of certain credit to specified entities. Effective date.
10. **SB 590 By Jolley of the Senate**
Ad valorem tax; requiring certain notice of valuation; authorizing specified protest subject to certain limit. Effective date.
11. **SB 609 By Jolley of the Senate and Nelson of the House**
Schools; creating the Oklahoma Education Empowerment Scholarship Act; establishing eligibility. Effective date. Emergency.
12. **SB 623 By Marlatt of the Senate**
Motor vehicles; authorizing the operation of certain vehicles on streets and highways. Effective date.
13. **SB 694 By Schulz of the Senate and Wright of the House**
Ad valorem tax; requiring certain notice of valuation; authorizing certain protest; limiting protest under certain circumstances. Effective date.
14. **SB 824 By Mazzei of the Senate**
Gross production taxes; modifying procedures for collection and distribution of tax revenue; repealing certain requirement. Effective date.
15. **SB 825 By Mazzei of the Senate**
Oklahoma Vehicle License and Registration Act; modifying apportionment of certain motor vehicle taxes and fees. Effective date. Emergency.
