Income tax credits; modifying time period during which credits may be claimed for donations to certain organizations. Effective date.
9. **SB 921 By Mazzei et al of the Senate**  
Income tax credits; modifying time period during which certain credit for property tax relief may be claimed. Effective date.
10. **SB 974 By Barrington of the Senate**  
Motor vehicles; clarifying entity designated for design of certain special license plate. Effective date.
11. **SB 998 By Fields of the Senate**  
Motor vehicles; creating Bison specialty license plate and related Revolving fund. Effective date.
12. **SB 1006 By Allen of the Senate**  
Oklahoma Quality Jobs Program Act; limiting ability of establishments to receive both tax credits and incentive payments. Effective date.
13. **SB 1052 By Allen of the Senate**  
Income tax credits; modifying time period during which credits are allowed for railroad reconstruction or replacement expenditures. Effective date.
14. **SB 1062 By Paddack of the Senate**  
Motor vehicles; creating A Brotherhood Aiming Toward Education of Oklahoma special license plate; creating revolving fund. Effective date.
15. **SB 1064 By Allen of the Senate**  
Income tax credits; modifying time period during which credits are allowed for construction of energy efficient residential construction. Effective date.
