## First Regular Session of the Forty-ninth Legislature of the State of Oklahoma

Nineteenth Legislative Day, Tuesday, March 4, 2003

Advising passage of and transmitting for consideration Engrossed **HBs 1017, 1026, 1075, 1115, 1118, 1146, 1149, 1178, 1273, 1290, 1291, 1321, 1329, 1346, 1390, 1469, 1502, 1512, 1527, 1646 and 1756** and **HCRs 1005 and 1010**.

**HB 1017** – By Leist, Harrison, McClain, Dorman and McIntyre of the House and Robinson of the Senate.

An Act relating to poor persons; amending 56 O.S. 2001, Section 222, which relates to certain audits; changing certain responsibility from Department of Public Welfare to the Oklahoma Health Care Authority; amending 56 O.S. 2001, Section 1010.13, which relates to persons authorized to enroll beneficiaries of Medicaid program; clarifying cite; amending 56 O.S. 2001, Section 1025.2, as amended by Section 2, Chapter 378, O.S.L. 2002 (56 O.S. Supp. 2002, Section 1025.2), which relates to community services and Medicaid personal care providers; authorizing Executive Director of Authority to make certain waivers and receive certain information; requiring Department of Human Services to disclose certain information to the State Medicaid Agency; authorizing the Oklahoma Health Care Authority to assess a quality assurance assessment fee on certain health maintenance organizations; providing percentage; providing procedures; providing certain dates for assessment; providing for calculations; limiting certain assessments; specifying uses for assessment; providing conditions which would make assessment null and void; providing for penalties; providing for deposits and expenditures; defining terms; providing for codification; and declaring an emergency.

**HB 1026** – By Miller (Ray) of the House and Robinson of the Senate.

An Act relating to children; amending 10 O.S. 2001, Section 406, which relates to child care facilities; making certain actions and reports unlawful; providing for penalty and fees; and declaring an emergency.

**HB 1075** – By Plunk and Liotta of the House and Maddox of the Senate.

An Act relating to statutes and reports; amending Section 3, Chapter 495, O.S.L. 2002, Section 4, Chapter 495, O.S.L. 2002, and 75 O.S. 2001, Section 303, as amended by Section 8, Chapter 495, O.S.L. 2002 (75 O.S. Supp. 2002, Sections 503, 504 and 303), which relate to the Small Business Regulatory Flexibility Act; modifying reference to

Included in the professional development institutes training shall be technology

training. Professional development institutes shall be accepted by the State Board of Education for professional development purposes and shall be defined as continuing education experiences which consist of a minimum of thirty (30) clock hours. The institutes shall be competency-based, emphasize effective learning practices, require collaboration among participants, and require each participant to prepare a work product which can be utilized in the classroom by the participant. Any state professional development institutes administered by the Commission shall be chosen through a competitive bid process and if funds are available subject to peer review. The Commission, prior to offering any professional development institute, shall promulgate rules related to administering state professional development institutes.

~~B. With the funds appropriated in House Bill No. 1872 of the 1st Session of the 46th Oklahoma Legislature specifically for the purpose of funding professional development institutes in intensive elementary reading, the~~ The Oklahoma Commission for Teacher Preparation shall develop, offer and administer professional development institutes to train elementary school teachers in reading education. ~~The funds shall be used for the cost of developing, administering and contracting for the professional development institutes.~~ When possible, certified reading specialists shall be included as consultants. All costs of the institutes shall be included in the contract price and no tuition or registration fee shall be collected from teachers attending the institutes. The institutes shall be offered by or through the Commission. Working in conjunction with the State Department of Education, the Commission shall develop a state plan for administration of such institutes and shall report to the Governor and the Legislature on the format of and participation in the institutes. The State Department of Education shall cooperate with and provide any information requested to the Oklahoma Commission for Teacher Preparation as is necessary to carry out the provisions of this subsection. As additional funds become available for such purpose, the Commission shall develop and offer professional development institutes in mathematics for teachers in grades five through nine, the use of technology in the classroom, training of residency committee members in teacher mentoring and in hands-on inquiry-based science for elementary teachers. The Commission shall ensure training for mentor teachers is provided on a priority basis to teachers at schools identified by the State Board of Education as a school improvement site or a low-performing or high challenge school.

C. Subject to the availability of funds, the Oklahoma Commission for Teacher Preparation shall:

1. Make available in Fiscal Year 1999, a three-day follow-up professional development institute for teachers who participated in an elementary school reading professional development institute during Fiscal Year 1998;
2. Provide five-day initial professional development institutes in elementary school reading for elementary school teachers and instructional leaders;
3. Contract for an independent evaluation of the elementary school reading professional development institute; and
4. Provide continued support of the elementary school reading professional development institutes through ongoing teacher development at individual school sites. Funds may be used for the cost of mentor training, payment for substitute teachers, on-site facilitation, and any other costs necessary to ensure improved reading by students.”, which amendment was declared adopted.
