HB 1004 – By Plunk, Mitchell and Davis of the House and Wilkerson of the Senate.
(cities and towns - amending 11 O.S., Section 21-103 - city annexation procedure - farming units - effective date – emergency)

HB 1085 – By Bonny of the House and Gumm of the Senate.
An Act relating to revenue and taxation; amending 68 O.S. 2001, Section 2357.41, which relates to credits against state income tax; modifying applicability of certain tax credit; and providing an effective date.

HB 1086 – By Carey of the House and Gumm of the Senate.
An Act relating to state government; amending 74 O.S. 2001, Sections 840-2.27B and 840-2.27D, which relate to the State Government Reduction-in-Force and Severance Benefits Act; adding a definition; modifying scope of employees eligible for severance benefits; and declaring an emergency.
