Twelfth Legislative Day, Wednesday, February 23, 2005

GENERAL ORDER

SB 484 by Lawler of the Senate and DeWitt of the House was called up for consideration.

Senator Lawler moved to amend **SB 484**, Page 2, Line 1, by inserting a new subsection C to read as follows:

“C. The legislature hereby occupies and preempts the entire field of legislation in this state touching in any way the regulation and enforcement of the registration, labeling, sale, storage, transportation, distribution, notification of use, and use of fertilizer to the complete exclusion of any order, ordinance or regulation by any municipality or other political subdivision of this state.”, by relettering subsequent subsection and by amending the title to conform, which amendment was declared adopted.

Senator Lawler moved that **SB 484** be advanced, which motion was declared adopted.

THIRD READING

SB 484 was read for the third time at length.

An Act relating to sunset; amending 59 O.S. 2001, Section 624, which relates to the State Board of Osteopathic Examiners; re-creating the Board; and modifying termination date.

HB 1208 – By Wright of the House and Easley of the Senate.

An Act relating to sunset; amending 59 O.S. 2001, 1455, as last amended by Section 3, Chapter 229, O.S.L. 2003 (59 O.S. Supp. 2004, Section 1455), which relates to the Polygraph Examiners Board; re-creating the Board; and modifying termination date.

An Act relating to Oklahoma State Bureau of Investigation; amending 74 O.S. 2001, Section 150.5, as amended by Section 1, Chapter 77, O.S.L. 2002 (74 O.S. Supp. 2004, Section 150.5), which relates to requests for investigations; allowing Bureau to reveal

confidential information to agencies and individuals under certain circumstances; requiring compliance with confidentiality provisions; and providing an effective date.

HB 1238 – By DeWitt of the House and Wyrick of the Senate.

An Act relating to environment and natural resources; amending 27A O.S. 2001, Section 2-6-101, as amended by Section 1, Chapter 227, O.S.L. 2002 (27A O.S. Supp. 2004, Section 2-6-101), which relates to water quality; modifying definition; amending 59 O.S. 2001, Section 1102, which relates to the Waterworks and Wastewater Works Operator Certification Act; modifying definitions; and providing an effective date.

HB 1272 – By Brannon of the House and Corn of the Senate.

An Act relating to the State Fire Marshal Commission; amending 74 O.S. 2001, Section 324.2, which relates to meetings of the State Fire Marshal Commission; updating quorum requirement; and declaring an emergency.

HB 1285 – By Deutschendorf of the House and Lawler of the Senate.

An Act relating to schools; amending 70 O.S. 2001, Sections 8-103, as amended by Section 12, Chapter 434, O.S.L. 2003 and 8-103.1 (70 O.S. Supp. 2004, Section 8-103), which relate to the Education Open Transfer Act; changing certain application procedure deadlines; providing for the automatic transfer of certain students; exempting students granted an automatic transfer from application requirement; prohibiting cancellation of transfers for certain reasons; providing an effective date; and declaring an emergency.

HB 1286 – By Balkman, Banz, Kiesel and Nance of the House and Jolley of the Senate.

An Act relating to motor vehicles; designating use of certain funds; creating the Patriot License Plate Revolving Fund; specifying purpose of fund; amending Sections 12 and 14, Chapter 504, O.S.L. 2004 (47 O.S. Supp., Sections 1135.3 and 1135.5), which relate to special license plates; allowing for personalization of special license plates; authorizing Tax Commission to accept applications for special license plates; creating the Central Oklahoma Habitat for Humanity License Plate; modifying design of certain plates; creating the Patriot License Plate; allowing for application to Oklahoma Tax Commission for special license plate; providing requirements for application; providing for fees for special license plates; requiring financial plan for certain plates; restricting transfer of plates; requiring renewal of plates; requiring system to be developed; exempting certain plates from application of act; defining term; creating revolving fund; directing expenditures of funds; providing for codification; and providing an effective date.

Supp. 2004, Sections 698.12 and 698.22), which relate to the Oklahoma Veterinary Practice Act; clarifying certain prohibited actions; modifying certain notice requirements; requiring veterinary technicians to renew registration; authorizing the State Board of Veterinary Medical Examiners to establish certain fee by rule; and providing an effective date.

An Act relating to the Compulsory Insurance Law; amending 47 O.S. 2001, Section 7-608, which relates to notice to the Department of Public Safety of termination of vehicle liability policies; requiring insurance carriers to include certain information in notice to the Department; requiring the Department of Public Safety to establish a secure website with certain information; requiring website to be accessible through the use of a password to insurance carriers and law enforcement; and providing an effective date.

Supp. 2004, Section 1-1914.2), which relates to placement of temporary nursing home managers; modifying time limit for certain hearings; modifying certain expenditures; providing for violations of the Oklahoma Nursing Home Care Act; providing for promulgation of certain rules; providing for certain uses of certain funds; providing for liens against certain assets; providing for certain documentation and final accounting; limiting extensions of final accounting; providing for certain court filings; authorizing Commissioner to institute certain legal proceedings; providing for certain procedures for legal proceedings; providing for certain liability for temporary managers; and providing an effective date.
