**First Regular Session of the Fiftieth Legislature
of the State of Oklahoma
Forty-ninth Legislative Day, Tuesday, May 3, 2005**

The prayer was offered by Reverend Michael Staton, First Baptist Church, Mustang, the guest of Senator Wilcoxson.

The Senate was called to order by President Pro Tempore Morgan.
