Enrolled Senate Bill No. 431

This is to advise you that on this date, pursuant to the authority vested in me by Section 11 of Article VI of the Oklahoma Constitution to approve or object to legislation presented to me, I have VETOED Senate Bill 431. This legislation represents a significant change in Oklahoma law as it relates to the construction, repair and remodel of homes and rights of consumers. It places substantial requirements on the consumer and unduly restricts the consumer's rights when there are construction defects. It may necessitate that the consumer consult with an attorney when attempting to resolve a construction defect. While this legislation contains good concepts and should be discussed further, the legislation as drafted is fraught with problems.
