B. No measure which proposes a change to a state tax law shall be considered by any committee of the Senate or the House of Representatives or by the full Senate or the House of Representatives unless such measure has attached to it a copy of the written estimates required by subsection A of this section. If a measure which proposes a change in a state tax law is amended by either House of the Legislature or a committee of either House of the Legislature, the author of the Measure shall request the Oklahoma Tax Commission to prepare a new estimate as provided in subsection A of this section and the measure shall not be considered by any committee of the Senate or the House of Representatives or by the full Senate or the House of Representatives unless such new estimate has been attached to the amended measure.”, and by renumbering subsequent sections.

Upon development of such a program, there shall be no limitation on the number of appraisers which may be supervised by a single supervising appraiser.”, and by renumbering subsequent section, which amendment was declared adopted.
