Second Extraordinary Session of the Fiftieth Legislature of the State of Oklahoma

Third Legislative Day, Wednesday, June 21, 2006

An Act relating to public safety; amending 47 O.S. 2001, Sections 2-105, 2-105.4, 2-105.6 and 2-105.7, as last amended by Sections 1, 2, 3 and 4 of Enrolled House Bill No. 2664 of the 2nd Session of the 50th Oklahoma Legislature, 2-105.8, as amended by Section 4, Chapter 161, O.S.L. 2004 and 2-106, as amended by Section 6, Chapter 397, O.S.L. 2002 (47 O.S. Supp. 2005, Sections 2-105.8 and 2-106), which relate to the Department of Public Safety; modifying authority of Commissioner of Public Safety to make certain appointments; modifying qualifications for certain positions; modifying statutory references to certain positions; modifying and establishing salaries of certain employees of the Department; providing for certain salary adjustments; modifying circumstances under which certain positions may be reclassified; amending 63 O.S. 2001, Section 2-103, as amended by Section 13, Chapter 199, O.S.L. 2003 (63 O.S. Supp. 2005, Section 2-103), which relates to the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control; specifying salaries for certain positions; amending 47 O.S. 2001, Section 2-300, as last amended by Section 1, Chapter 142, O.S.L. 2005 (47 O.S. Supp. 2005, Section 2-300), which relates to the Oklahoma Law Enforcement Retirement System; modifying definitions; amending 63 O.S. 2001, Section 935, which relates to responsibilities of the Chief Medical Examiner; establishing salaries of certain employees of the Examiner; amending 74 O.S. 2001, Section 150.6a, as amended by Section 1, Chapter 346, O.S.L. 2004 (74 O.S. Supp. 2005, Section 150.6a), which relates to salaries of certain employees within the Oklahoma State Bureau of Investigation; modifying salaries of certain employees; amending 74 O.S. 2001, Section 840-5.5, as last amended by Section 1 of Enrolled Senate Bill No. 1357 of the 2nd Session of the 50th Oklahoma Legislature, which relates to unclassified positions; making certain position classified; providing for codification; and providing an effective date.

SB 109X – By Corn.

An Act relating to public safety; creating the Matt Evans/Jeff Rominger Interoperable Communications Act; providing short title; authorizing Department of Public Safety to acquire public safety communication system; providing for codification; and providing an effective date.

SB 110X – By Corn of the Senate and Brannon of the House.

An Act relating to higher education; amending 70 O.S. 2001, Section 3201, as amended by Section 2, Chapter 194, O.S.L. 2002 (70 O.S. Supp. 2005, Section 3201), which relates to institutions comprising The Oklahoma State System of Higher Education; modifying name of Carl Albert State College; amending 70 O.S. 2001, Sections 3302 and

3305, as last amended by Section 14, Chapter 218, O.S.L. 2005 (70 O.S. Supp. 2005, Section 3305), which relate to the Board of Regents of the University of Oklahoma; adding Carl Albert College to institutions governed by Board of Regents of the University of Oklahoma; amending 70 O.S. 2001, Sections 4423, 4423.1, and 4423.1A, which relate to authorization for two-year colleges; removing Board of Regents of Carl Albert State College; changing name of Carl Albert State College to Carl Albert College; specifying Carl Albert State College shall continue as a two-year college at same location; transferring governance of Carl Albert College and branch campus to Board of Regents of the University of Oklahoma; transferring all interests and obligations; providing an effective date; and declaring an emergency.

SB 111X – By Corn.

An Act relating to revenue and taxation; amending 68 O.S. 2001, Sections 500.6, as last amended by Section 8, Chapter 472, O.S.L. 2003 and 500.7 (68 O.S. Supp. 2005, Section 500.6), which relates to motor fuel taxes; modifying apportionment of gasoline tax; deleting obsolete language; modifying apportionment of diesel tax; providing a contingent effective date.

SB 112X – By Corn.

An Act relating to the Rural Economic Action Plan Water Projects Fund; amending 68 O.S. 2001, Section 1004, as amended by Section 2, Chapter 416, O.S.L. 2002 (68 O.S. Supp. 2005, Section 1004), which relates to gross production tax; modifying funds subject to certain deposit limit; amending Section 1, Chapter 500, O.S.L. 2004 (62 O.S. Supp. 2005, Section 2002.1), which relates to public finance; enumerating purposes for which Rural Economic Action Plan Water Projects Fund shall be used; providing for apportionment of Fund; providing an effective date; and declaring an emergency.

SB 113X – By Shurden.

An Act relating to crimes and punishments; amending 10 O.S. 2001, Section 7115, as amended by Section 1 of Enrolled Senate Bill No. 1800 of the 2nd Session of the 50th Oklahoma Legislature, which relates to child abuse; modifying language, requiring certain DNA evidence match for imposition of the death penalty; providing an effective date; and declaring an emergency.

SJR 1X – By Coffee.

A Joint Resolution directing the Secretary of State to refer to the people for their approval or rejection a proposed amendment to Section 53 of Article V of the Constitution of the State of Oklahoma; allowing limitation of liability in certain contracts; providing ballot title; and directing filing.

SJR 2X – By Corn.

A Joint Resolution directing the Secretary of State to refer to the people for their approval or rejection a proposed amendment to the Oklahoma Constitution by adding a new section to Article X to be designated as Section 44; prohibiting use of motor fuel tax revenue except for certain purposes; creating Oklahoma Safe Roads Trust Fund; providing for deposits thereto and uses thereof; requiring the trust fund to be expended only for

certain transportation-related purposes; prohibiting the Legislature from using the trust fund to replace certain funds supporting transportation purposes; requiring the State Board of Equalization to examine appropriations from the trust fund; providing appropriation procedure under certain circumstances; providing for construction of certain provisions; providing ballot title; and directing filing.

SJR 3X – By Corn.

A Joint Resolution directing the Secretary of State to refer to the people for their approval or rejection a proposed amendment to Section 23 of Article X of the Constitution of the State of Oklahoma; providing name of measure; limiting amount of funds which may be appropriated for recurring expenses; providing ballot title; and directing filing.

SJR 4X – By Corn.

A Joint Resolution relating to a permanent rule of the Oklahoma Health Care Authority Board; disapproving, in part, permanent Rule OAC 317:35-5-41, regarding a certain limit of the Medicaid Income Pension Trust; directing promulgation of rules setting new limit; directing distribution; and declaring an emergency.

SCR 1X – By Hobson of the Senate and Balkman of the House.

A Concurrent Resolution authorizing the Board of Regents of the University of Oklahoma, acting on behalf of the University of Oklahoma Health Sciences Center, to issue certain revenue bonds pursuant to Sections 4001 through 4017 of Title 70 of the Oklahoma Statutes; and directing distribution.
