3. The person was required to enter upon the premises for business reasons or for health or safety reasons; or
4. The person was authorized by law to enter upon the land.

This paragraph shall not apply to law enforcement officers in the line of duty. A person who knowingly enters the real property without consent shall be guilty of a misdemeanor, upon conviction.", which amendment was withdrawn upon request of Senator Bass.
