A. A person who is eligible to register to vote may register on election day by appearing in person at the polling place for the precinct in which the individual resides and completing a voter registration application, making written oath, and providing proof of identity.

B. For purposes of this section, a person may establish identity by presenting to a precinct or any election official any of the following:

1. A current and valid government or tribal identification document;
2. An Oklahoma driver license;
3. An Oklahoma non-operator's identification card;
4. A residential lease or utility bill that shows the name and address of the voter;
5. A student identification card from a postsecondary educational institution in Oklahoma;
6. A copy of a bank statement, government check, paycheck, or other government document that shows the name and address of the voter; or
7. Any current and valid form of photographic identification approved by the State Election Board.

If the photographic identification presented does not contain the person's current address in the precinct, the person may be requested to present a current document that shows the person's name and address in the precinct.

C. In lieu of subsection B of this section, a person wishing to vote may establish identity and residency in the precinct by written oath of a person who is registered to vote in the precinct. The registered voter's oath shall attest to the stated identity of the person wishing to vote and that the person is a current resident of the precinct. The oath must be signed by the attesting registered voter in the presence of any precinct election official.

D. The oath required pursuant to subsection A and subsection C of this section shall be attached to the voter registration application, and the information contained in the oath

shall be recorded on the voter registration records of the person registering to vote and on the voter registration records of the registered voter attesting by oath on behalf of a person registering to vote if applicable.

E. At any time before election day, a person who appears in person at the their county election board office or at a satellite absentee voting station after the deadline for registration in Section 4-110.1 of Title 26 of the Oklahoma Statutes, may register to vote and vote an absentee ballot by following the procedure in this section for registering to vote on election day. A person who wishes to vote in person at the polling place on election day and who has not registered to vote before the deadline is required to register to vote at the polling place on election day following the procedure in this section.

SECTION 8. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 7-115.5 of Title 26, unless there is created a duplication in numbering, reads as follows:

A. A person whose name does not appear on the election register of the precinct in which that person claims the right to vote shall not be permitted to vote, unless the person affirms that the person is currently registered in the county and presents proof of identity, or a county election board official informs a precinct election official that an error has occurred and that the person is a registered voter of that precinct. If the county election board office finds no record of the person's registration but the person insists that the person is a registered voter of that precinct, the precinct election officials shall allow the person to cast a ballot. If the voter informs the precinct election official that the voter resides in the precinct and is not registered to vote, the voter may register to vote and cast a ballot. If such a voter is unable to establish identity in the manner provided in Section 2 of this act, the voter shall be allowed to cast a provisional ballot.

B. A person who has been sent an absentee ballot by mail but for any reason has not received it shall be permitted to cast a ballot in person.

BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE 1ST SESSION OF THE 52ND OKLAHOMA LEGISLATURE:

SECTION 1. The Secretary of State shall refer to the people for their approval or rejection, as and in the manner provided by law, the following proposed amendment to Section 11A of Article V of the Oklahoma Constitution to read as follows:

Section 11A. The apportionment of the Legislature shall be accomplished by the Legislature according to the provisions of this article, within ninety (90) legislative days after the convening of the first regular session of the Legislature following each Federal Decennial Census. If the Legislature shall fail or refuse to make such apportionment within the time provided herein, then such apportionment shall be accomplished by ~~an Apportionment~~ the Bipartisan Commission composed of the Attorney General, Superintendent of Public Instruction and the State Treasurer of the State of Oklahoma on Legislative Apportionment, according to the provisions of this article. The Commission shall be composed of seven (7) members as follows: the Lieutenant Governor, who shall be nonvoting and the chair of the Commission; two members, one republican and one democrat, appointed by the President Pro Tempore of the Senate; two members, one republican and one democrat, appointed by the Speaker of the House of Representatives; and two members, one republican and one democrat, appointed by the Governor.

SECTION 2. The Secretary of State shall refer to the people for their approval or rejection, as and in the manner provided by law, the following proposed amendment to Section 11B of Article V of the Oklahoma Constitution to read as follows:

Section 11B. Each order of apportionment rendered by the ~~Apportionment~~ Bipartisan Commission on Legislative Apportionment shall be in writing and shall be filed with the Secretary of State and shall be signed by at least ~~two~~ four members of the Commission.

SECTION 3. The Ballot Title for the proposed Constitutional amendments as set forth in SECTIONS 1 and 2 of this resolution shall be in the following form:

THE GIST OF THE PROPOSITION IS AS FOLLOWS:

This measure amends Sections 11A and 11B of Article 5 of the State Constitution. The measure would change the name of the Apportionment Commission. The new name would be the Bipartisan Commission on Legislative Apportionment. Currently, the members of the Apportionment Commission are the Attorney General, the Superintendent of Public Instruction and the State Treasurer. The membership would be changed to seven members. The voting members of the Commission would consist of equal numbers of republicans and democrats. One democrat and one republican would be appointed by the President Pro Tempore of the Senate. One democrat and one republican would be appointed by the Speaker of the House of Representatives. One democrat and one republican would be appointed by the Governor. The Lieutenant Governor would be a nonvoting member. The Lieutenant Governor would serve as chair of the Commission. Currently, at least two members of the Commission are required to sign orders of apportionment. The measure would change the number to four members.
