## Second Regular Session of the Fifty-second Legislature of the State of Oklahoma

**Twenty-seventh Legislative Day, Wednesday, March 17, 2010**

The Senate was called to order by Senator Aldridge.

### **UNANIMOUS CONSENT REQUEST DIRECT TO CALENDAR**

Senator Eason McIntyre asked unanimous consent to refer **SR 85** direct to the Calendar for consideration, which was the order.
