## First Regular Session of the Fifty-third Legislature of the State of Oklahoma

**Eighteenth Legislative Day, Wednesday, March 9, 2011**

C. The fee to be submitted with an application for a roofing contractor registration may be prorated as set by ~~the registrar~~ the provisions of the Roofing Contractor Registration Act. Unless prorated at the time of initial registration, fees shall be paid in the amount stated in subsection A of this section and such registration certificates shall expire June 30 each year.

D. A renewal fee for a roofing contractor registration shall be ~~set by the registrar, which shall not exceed Three Hundred Dollars (\$300.00)~~ Seventy-five Dollars (\$75.00) for the annual renewal registration certificate.

E. Any person having registered prior to July 15, 2011, shall be entitled to a fee refund for any amount paid in excess of the fee stated in subsection A of this section. The registrar shall make the fee refund on the date of expiration of the current registration period for which the fee charged was in excess of the amount stated in subsection A of this section.”, and by renumbering subsequent sections and by amending the title to conform, which amendment was declared adopted.
