HB 1748 – By Nelson and Kern of the House and Russell of the Senate.

An Act relating to children; amending 10 O.S. 2011, Section 7505-3.2, which relates to adoption cost disclosure requirements; modifying requirements; requiring certain affidavit; specifying contents of affidavit; and providing an effective date.

HB 2198 – By Vaughan of the House and Wyrick of the Senate.

An Act relating to game and fish; amending 29 O.S. 2011, Section 6-303.1, which relates to possession of paddlefish eggs; adding penalty for taking, possessing or transporting certain paddlefish products with certain value; and clarifying language.

HB 2250 – By Shannon, McNiell and Walker of the House and Marlatt of the Senate.

An Act relating to motor vehicles; amending 47 O.S. 2011, Section 14-111, which relates to overweight vehicles; requiring consideration of weighing area levelness; providing an effective date; and declaring an emergency.

Senator Johnson (Constance) moved to amend **SB 1274**, Page 11, Line 8 ½, by inserting a new SECTION 10 to read as follows;

SECTION 1. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 1-745.20 of Title 63, unless there is created a duplication in numbering, reads as follows:

- A. The Legislature finds that:
1. Thousands of children are deprived of birth in this state every year because of the lack of state regulation over vasectomies;
 2. There is substantial evidence that unregulated vasectomies result in fewer unwanted pregnancies and, by extension, fewer births;

3. It is patently unfair that men can avoid the rewards of unwanted fatherhood by presuming that their judgment over such matters is more valid than the judgment of the Legislature;

4. Fewer unwanted pregnancies result in fewer children living in poverty and a lower prison population, and this is job killing in a time when social workers, police officers, and prison guards need the employment to feed their families; and

5. It is the purpose of the Legislature to assert an invasive state interest in the reproductive habits of men in this state and substitute the will of the government over the will of adult men.

B. 1. As used in this section, the term “vasectomy” means a surgical procedure performed on males in which the vas deferens are cut, tied, cauterized, or otherwise interrupted in such a manner that the semen no longer contains sperm and conception cannot occur.

2. No vasectomy is authorized or shall be performed in violation of this section.

3. In determining whether a vasectomy is necessary, no regard shall be made to the desire of a man to father children, to his economic situation, to his age, to the number of children he is currently responsible for, or to any danger to his wife or partner in the event a child is conceived. A vasectomy may only be performed to avert the death of the man or avert serious risk of substantial and irreversible physical impairment of a major bodily function of the man. No such condition shall be deemed to exist if it is based on a diagnosis or claim of a mental or emotional condition of the man or that the man will purposefully engage in conduct which he intends to result in his death or in substantial and irreversible physical impairment of a major bodily function.

4. No vasectomy is authorized or shall be performed unless the vasectomy is performed in a licensed hospital, in a licensed ambulatory surgical center, or in a health facility licensed as a vasectomy facility by the State Department of Health.

5. A vasectomy shall only be performed by a licensed healthcare provider.

6. Any person who performs a vasectomy, and any person permitting a vasectomy to be performed on him, in violation of the provisions of this section shall be guilty of a felony and, upon conviction, shall be sentenced to community service of not fewer than one thousand forty (1,040) hours in the field of service to needy families, caring for or counseling abused and neglected children or wayward teens, or performing service to inmates in a jail or correctional institution.”, and by renumbering subsequent section and by amending the title to conform.

Senator Newberry moved to table the Johnson (Constance) amendment, which tabling motion was declared adopted.

Senator Newberry moved to amend **SB 1274**, Page 6, Lines 11 through 13, by deleting all language after the word “shall” on Line 11 and before the period on Line 13 and by inserting the following language: “notify the pregnant woman orally and in a separate written notification in easily comprehensible language that the embryonic or fetal heartbeat of the unborn child can be made audible for the pregnant woman to hear. If the pregnant woman indicates that she wants to hear the heartbeat, the abortion provider shall, using a Doppler fetal heart rate monitor, make the heartbeat of the unborn child audible for the pregnant woman to hear. If the pregnant woman indicates she does not want to hear the

heartbeat, she shall sign a separate notification document acknowledging this fact and such acknowledgement shall be included in the medical file of the pregnant woman for a minimum of seven (7) years.”

Senator Newberry moved to amend the above amendment to **SB 1274** by deleting all language and inserting the language “tell the woman that it may be possible to make the embryonic or fetal heartbeat of the unborn child audible for the pregnant woman to hear and ask the woman if she would like to hear the heartbeat. If the woman would like to hear the heartbeat, the abortion provider shall, using a Doppler fetal heart rate monitor, make the embryonic or fetal heartbeat of the unborn child audible for the pregnant woman to hear”, which amendment was declared adopted upon roll call as follows:
