## Second Regular Session of the Fifty-third Legislature of the State of Oklahoma Nineteenth Legislative Day, Wednesday, March 7, 2012

b. any substance for which there is an approved new drug application,

c. with respect to a particular person any substance, if an exemption is in effect for investigational use, for that person, under section 505 of the Federal Food, Drug, and Cosmetic Act (21 U.S.C. 355) to the extent conduct with respect to such substance is pursuant to such exemption, or

d. any substance to the extent not intended for human consumption before such an exemption takes effect with respect to that substance.”, which amendment was declared adopted.
