Senator Brinkley moved to amend **HB 2447**, Page 13, Line 21, by adding after the period “.” the following: “Until January 1, 2014, if an employer with more than fifty (50) employees purchases an exclusive provider benefit plan from an insurer, the insurer shall also offer to the employees of the employer an out-of-network benefit. This out-of-network coverage may be subject to an additional premium, deductible, copayment and co-insurance and such charges may be paid by the employee rather than the employer.”

Senator Sparks moved to amend the above amendment to **HB 2447** by deleting the language “Until January 1, 2014, if” and inserting in lieu thereof the word “If”; and by deleting the following language “with more than fifty (50) employees”, which amendment was declared adopted.
