First Regular Session of the Fifty-fourth Legislature of the State of Oklahoma

Thirteenth Legislative Day, Thursday, February 21, 2013

The Senate was called to order by Senator Brinkley.

GENERAL ORDER

SB 522 by Standridge of the Senate and Derby of the House was called up for consideration.

Senator Standridge moved to amend **SB 522**, Page 2, Lines 20 and 24, by deleting after the word “previous” and before the word “by” the words “eighteen (18)”, and inserting the words “twenty four (24)”.

Senator Sparks raised a point of order as to whether the Standridge amendment was considered an untimely amendment.

The Chair ruled that the amendment cycle on **SB 522** was extended by the Floor Leader and that the amendment was in order.

Senator Standridge pressed adoption of his amendment, which amendment failed of adoption.

Senator Standridge moved that **SB 522** be advanced, which motion was declared adopted.

MESSAGE FROM THE HOUSE

Advising passage of and transmitting for consideration Engrossed **HBs 1078, 1999** and **2078**.

HB 1078 – By Sanders of the House and Marlatt of the Senate.

An Act relating to motor vehicles; amending 47 O.S. 2011, Section 583, which relates to used motor vehicle dealer licenses; and prohibiting manufactured home manufacturing facilities from conducting certain transactions.

HB 1999 – By McNiel, Newell, Blackwell, McBride, Wood, Bennett, Cockroft, McDaniel (Curtis) and Cannaday of the House and Fields of the Senate.

An Act relating to meat inspection; amending 2 O.S. 2011, Sections 6-182 and 6-192, which relate to the Oklahoma Meat Inspection Act; modifying definition; prohibiting the sale, possession and transferring of certain horsemeat; specifying that certain requirements apply to horsemeat for sale in this state; authorizing the State Commissioner of Health to

have access to certain vehicles and establishments; defining terms; modifying definition; repealing 63 O.S. 2011, Sections 1-1135, 1-1136, 1-1137, 1-1138 and 1-1139, which relate to horsemeat; and providing an effective date.

HB 2078 – By McDaniel (Randy) of the House and Mazzei of the Senate.

An Act relating to the Oklahoma Firefighters Pension and Retirement System; amending 11 O.S. 2011, Sections 49-100.1, as amended by Section 1, Chapter 364, O.S.L. 2012, 49-106.1, 49-117.1 and 49-122 (11 O.S. Supp. 2012, Section 49-100.1), which relate to definitions, the Deferred Retirement Option Plan, employer and employee contributions and terminations before normal retirement; modifying definitions; modifying minimum number of years of service credit for retirement eligibility for certain persons; modifying age-based rule for retirement eligibility; modifying provisions related to Deferred Retirement Option for certain persons; modifying maximum duration of participation; modifying authorized rate of return; providing for vesting of certain members based upon first employment date; modifying employee contribution rate; modifying employer contribution rate; amending 36 O.S. 2011, Section 312.1, which relates to the apportionment of insurance premium tax revenues; modifying apportionment of revenues to the Oklahoma Firefighters Pension and Retirement System; and providing an effective date.

The above-numbered measures were read the first time.
