## First Regular Session of the Fifty-fourth Legislature of the State of Oklahoma

**Twentieth Legislative Day, Wednesday, March 6, 2013**

Supp. 2012, Section 2-701), which relates to the Oklahoma Methamphetamine Offender Registry Act; clarifying elements of prohibited acts; directing the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control to promulgate certain rules; and providing an effective date.

**HB 2232** – By Dorman, Sherrer and Hoskin of the House and Barrington of the Senate. An Act relating to revenue and taxation; allowing donation from refund for certain purpose; depositing funds; creating Constitutional Challenge Litigation Cost Revolving Fund; limiting expenditure from fund to certain purposes; allowing refund for donations made in error; amending 68 O.S. 2011, Section 2368.24, as amended by Section 564, Chapter 304, O.S.L. 2012 (68 O.S. Supp. 2012, Section 2368.24), which relates to a certain tax donation; changing name of recipient fund; requiring budgeting and expenditure of certain monies; modifying purpose; providing for codification; and providing an effective date.
