Fifty-ninth Legislative Day, Thursday, May 16, 2013

The Senate was called to order by Senator Brooks.

3. That paragraph 12 in Section 7, on page 8, lines 11-16 be deleted;
4. That Section 11, on page 10, lines 16-19 be deleted;
5. That an additional sum of \$14,750,000.00 be allocated to the school funding formula.
