## Second Regular Session of the Fifty-fourth Legislature of the State of Oklahoma

**Forty-fifth Legislative Day, Wednesday, April 23, 2014**

The Senate was called to order by Senator Griffin.

Senator Coates moved to amend **HB 1056**, Page 2, Line 3, by deleting after the word “crime” and before the word “Section” the words “pursuant to” and inserting the words “listed in”, and, Line 7, by inserting after the word “Act” a comma “,” and the words “whether or not such requirement was in effect at the time of conviction”, and, Line 7 ½ ,by inserting a new paragraph 6 and a new subsection C to read as follows:

“6. Are not incarcerated for a crime defined in Section 571 of Title 57 of the Oklahoma Statutes as ineligible to be considered a non-violent offense, whether or not the crime was committed prior to or after the passage of Section 571 of Title 57 of the Oklahoma Statutes.

C. Nothing in Sections 332.21 through 332.24 of the Oklahoma Statutes shall be construed to grant a parole hearing or parole to persons serving a sentence of life without parole.”, and, Lines 22 and 23, by deleting all language in subsection A and renumbering subsequent subsections, which amendment was declared adopted.

Senator Coates moved to amend **HB 1056**, Page 1, by restoring the title, which amendment was declared adopted.

Senator Coates moved that **HB 1056** be advanced, which motion was declared adopted.
