## MESSAGE FROM THE HOUSE

Advising passage of and transmitting for consideration Engrossed **HBs 1001, 1005, 1006, 1010, 1040, 1053, 1266, 1274, 1293, 1494** and **1612**.

**HB 1001** – By McDaniel (Randy) of the House and Newberry of the Senate.

An Act relating to labor; amending 40 O.S. 2011, Sections 1-210, 2-108, 2-203, as last amended by Section 1, Chapter 220, O.S.L. 2014, 2-417, 2-618, 2-802, 3-103, as amended by Section 8, Chapter 71, O.S.L. 2013, 3-106, as amended by Section 8, Chapter 196, O.S.L. 2012, Section 13, Chapter 196, O.S.L. 2012, 4-318, 4-504 and 4-508, as last amended by Section 1, Chapter 282, O.S.L. 2014 (40 O.S. Supp. 2014, Sections 2-203, 3-103, 3-106, 3-511 and 4-508), which relate to the Employment Security Act of 1980; modifying definition; exempting certain persons from coverage; defining terms; requiring limited liability companies be taxed in the same manner as under the Federal Unemployment Tax Act and Internal Revenue Code; modifying when certain individuals produce certain evidence; modifying requirements for filing claim for unemployment benefits; modifying disqualification to receive benefits; authorizing Oklahoma Employment Security Commission to require individual to personally appear at workforce center; providing for disqualification of benefits for failure to appear; requiring Commission to establish system to identify certain claimants; allowing employers to file a specific statement of the objection to a claim by telefax or email; authorizing Commission to levy employer wages or bank accounts to collect unemployment benefit overpayments; authorizing Commission to utilize the United States Treasury Offset Program to collect benefit overpayment indebtedness; modifying references to the Workforce Investment Act programs; modifying employer contribution rate; prohibiting eligibility of certain employers to be relieved of benefit wage charge; providing certain contribution rate for certain employers; authorizing levy for the collection of delinquent unemployment taxes; authorizing Commission to utilize the United States Treasury Offset Program to collect delinquent employer taxes; clarifying references to certain programs; repealing 40 O.S. 2011, Sections 3-110 and 3-112, as amended by Section 11, Chapter 71, O.S.L. 2013 (40 O.S. Supp. 2014, Section 3-112), which relate to contribution rates; providing for codification; and providing an effective date.

**HB 1005** – By McDaniel (Randy) of the House and Brinkley of the Senate.

An Act relating to the Teachers' Retirement System of Oklahoma; amending 70 O.S. 2011, Section 17-116.2, as last amended by Section 3, Chapter 101, O.S.L. 2013 (70 O.S.

Supp. 2014, Section 17-116.2), which relates to benefit computations; specifying treatment of certain contributions.

**HB 1006** – By Kern of the House and Stanislawski of the Senate.

An Act relating to common carriers; amending 13 O.S. 2011, Section 176.7, which relates to the Security of Communications Act; adding certain offenses for which an order of interception may be obtained; and providing an effective date.

**HB 1010** – By Faught of the House and Brinkley of the Senate.

An Act relating to sunset; amending 73 O.S. 2011, Section 83.1, as last amended by Section 11, Chapter 209, O.S.L. 2013 (73 O.S. Supp. 2014, Section 83.1), which relates to the Capitol-Medical Center Improvement and Zoning Commission; re-creating the Board; and modifying termination date.

**HB 1040** – By Faught and Derby of the House and Brown of the Senate.

An Act relating to Purple Heart Day; amending 25 O.S. 2011, Section 90.7, which relates to Purple Heart Week; changing Purple Heart Week to Purple Heart Day; and providing an effective date.

**HB 1053** – By McDaniel (Randy) of the House and Brinkley of the Senate.

An Act relating to the Oklahoma Law Enforcement Retirement System; amending 47 O.S. 2011, Sections 2-301, 2-303.1, as last amended by Section 1, Chapter 119, O.S.L. 2013, 2-305.1A, as amended by Section 2, Chapter 52, O.S.L. 2012 and 2-305.2 (47 O.S. Supp. 2014, Sections 2-303.1 and 2-305.1A), which relate to certain benefits; conforming statutory references to the Internal Revenue Code of 1986, as amended; stating intent to comply with certain requirements; providing for disposition of revenues in certain subaccounts related to Section 401(h) of the Internal Revenue Code of 1986, as amended; requiring Board of Trustees to develop procedures regarding rollover distributions; requiring adherence to certain guidance under I.R.S. notice; prescribing certain interest rate for purposes of Deferred Retirement Option Plan; authorizing amendments; and declaring an emergency.

**HB 1266** – By Walker and Derby of the House and Stanislawski of the Senate.

An Act relating to public health and safety; amending 63 O.S. 2011, Section 1-890.3, as amended by Section 1, Chapter 199, O.S.L. 2012 (63 O.S. Supp. 2014, Section 1-890.3), which relates to the promulgation of certain rules by the State Board of Health; requiring Board to promulgate certain rule prohibiting facility staff from disclosing financial information of resident; and providing an effective date.

**HB 1274** – By Walker of the House and Boggs of the Senate.

An Act relating to children; amending 10 O.S. 2011, Section 404.1, as amended by Section 4, Chapter 308, O.S.L. 2013 (10 O.S. Supp. 2014, Section 404.1), which relates to child care facility background checks; authorizing facility to release relevant information about potential employee; providing exception; applying same confidentiality standards for released information; and providing an effective date.

**HB 1293** – By Kirby of the House and Brown of the Senate.

An Act relating to insurance; amending 36 O.S. 2011, Section 309.4, which relates to examination reports; eliminating requirement that insurance companies deliver certain reports and orders; amending 36 O.S. 2011, Section 312A, which relates to enforcement and recording of penalties and fees; specifying types of civil penalties and fees that may be enforced in certain manner; amending 36 O.S. 2011, Section 348.1, as amended by Section 3, Chapter 275, O.S.L. 2014 (36 O.S. Supp. 2014, Section 348.1), which relates to fees and licenses; updating citation; amending 36 O.S. 2011, Sections 608 and 609, which relate to authorization of insurers; updating and deleting citations; amending 36 O.S. 2011, Section 903.2, as amended by Section 16, Chapter 254, O.S.L. 2013 (36 O.S. Supp. 2014, Section 903.2), which relates to the Oklahoma Insurance Rating Act; modifying filing requirements; amending 36 O.S. 2011, Section 1435.2, which relates to the Oklahoma Producer Licensing Act; modifying definition; updating citations; amending 36 O.S. 2011, Section 1441.1, which relates to the Third-Party Administrator Act; updating citations; amending 36 O.S. 2011, Section 1524, as amended by Section 6, Chapter 269, O.S.L. 2013 (36 O.S. Supp. 2014, Section 1524), which relates to the Risk-based Capital for Insurers Act; modifying required contents of certain required plan; amending 36 O.S. 2011, Section 1674, which relates to the Business Transacted with Producer Controlled Insurer Act; updating reference; amending 36 O.S. 2011, Section 4502, which relates to group accident and health insurance policies; modifying required policy provisions; amending 36 O.S. 2011, Section 6041, which relates to payments for emergency living expenses; expanding authorized forms of payments; amending 36 O.S. 2011, Section 6103.3, which relates to acts of insurance business; specifying certain persons for which certain remedies will be applicable; specifying certain prohibited acts; amending 36 O.S. 2011, Section 6811, which relates to the Medical Professional Liability Insurance Closed Claim Reports Act; authorizing the Insurance Commissioner to require certain filings; requiring certain reports be filed within certain time; eliminating requirement that certain claims be reported; repealing 36 O.S. 2011, Sections 924.4, as amended by Section 1, Chapter 44, O.S.L. 2012 and 924.5, as amended by Section 2, Chapter 44, O.S.L. 2012 (36 O.S. Supp. 2014, Sections 924.4 and 924.5), which relate to affidavits of exempt status; and providing an effective date.

**HB 1494** – By Ritze and Vaughan of the House and Shortey of the Senate.

An Act relating to motor vehicles; amending 47 O.S. 2011, Section 759, as last amended by Section 32, Chapter 15, O.S.L. 2013 (47 O.S. Supp. 2014, Section 759), which relates to the Board of Tests for Alcohol and Drug Influence; re-creating the Board; modifying termination date; modifying membership of the Board; providing for election of chair and vice-chair; removing authority to appoint certain employment position; authorizing Board to prescribe standards and procedures for screening tests and the collection of specimens; providing an effective date; and declaring an emergency.

**HB 1612** – By Henke of the House and Bice of the Senate.

An Act relating to state government; amending 74 O.S. 2011, Section 1003, which relates to Interlocal Cooperation Act; modifying definition; and providing an effective date.
