MESSAGE FROM THE HOUSE

Advising passage of and transmitting for consideration Engrossed **HBs 1051, 1081, 1113, 1347, 1650, 1651, 1748, 1807 and 1860.**

HB 1051 – By Kirby and Sherrer of the House and Griffin of the Senate.

An Act relating to schools; creating the Safe Sports School Act; requiring school districts to review certain criteria and evaluate how to improve sports safety; requiring school districts to utilize certain guidelines and information; requiring State Department of Education to grant certain award when funds available; requiring State Board of Education to promulgate certain rules; providing for codification; and providing an effective date.

HB 1081 – By Ownbey of the House and Simpson of the Senate.

An Act relating to professions and occupations; amending 59 O.S. 2011, Section 567.4, as amended by Section 1, Chapter 228, O.S.L. 2013 (59 O.S. Supp. 2014, Section 567.4), which relates to the Oklahoma Board of Nursing; including certain duties of Executive Director; permitting Board to impose corrective action; requiring Board to promulgate certain rules; providing for codification; and providing an effective date.

HB 1113 – By Hoskin and Sherrer of the House and Paddock of the Senate.

An Act relating to motor vehicles; amending 47 O.S. 2011, Section 11-314, which relates to approaching emergency vehicles on the roadway; requiring certain caution be taken when approaching certain maintenance vehicles; and providing an effective date.

HB 1347 – By Rousselot of the House and David of the Senate.

An Act relating to workers' compensation; amending Section 78, Chapter 208, O.S.L. 2013 (85A O.S. Supp. 2014, Section 78), which relates to the appeals process; providing for the continuation of medication during the appeals process; and providing an effective date.

HB 1650 – By Vaughan of the House and Fry of the Senate.

An Act relating to game and fish; amending 29 O.S. 2011, Section 6-204, which relates to the operating provisions for commercial turtle harvesters; clarifying statutory language; removing mesh size restrictions when harvesting aquatic turtles; and providing an effective date.

HB 1651 – By Dunlap and Vaughan of the House and Fields of the Senate.

An Act relating to game and fish; amending 29 O.S. 2011, Section 5-201, as amended by Section 2, Chapter 294, O.S.L. 2012 (29 O.S. Supp. 2014, Section 5-201), which relates to the means of taking wildlife; adding exotic wildlife to list of wildlife that may not be taken by certain prohibited means; and providing an effective date.

HB 1748 – By Newell and Lockhart of the House and Treat of the Senate.

An Act relating to public finance; imposing requirements for disclosure of federal funds and analysis regarding reliance and costs for compliance; providing for codification; and providing an effective date.

HB 1807 – By Banz of the House and Treat of the Senate.

An Act relating to professions and occupations; amending 59 O.S. 2011, Section 15.1A, which relates to the Oklahoma Accountancy Act; modifying definitions; and providing an effective date.

HB 1860 – By Wright of the House and Schulz of the Senate.

An Act relating to motor vehicles; amending 47 O.S. 2011, Sections 6-107 and 6-110.2, which relate to the issuance of driver licenses; authorizing submission of notarized affidavit for certain purposes; and providing an effective date.
