SB 1274 was referred for engrossment.

POINT OF ORDER

Senator Sparks raised a point of order pertaining to **SB 1551**, stating Senate Rule 7-7 (F) (11) states "The vote on a recommendation by the committee to the Senate concerning a legislative measure shall be by recorded roll call and shall require a majority vote of the members of the committee present, which shall not be less than a quorum, for passage."

In addition, Sec. 505, Paragraph 6 of Mason's Legislative Manual regarding procedure on the absence of a quorum, states: "When a vote discloses that there is not a quorum present, the vote is of no effect and the subject of the vote remains exactly as though no vote had been taken".

Because quorum was not present at the time the vote was taken on **SB 1551** in the Senate Appropriations Committee, as is evidenced by the Standing Committee Report on the measure, the vote is of no effect and, therefore, **SB 1551** is not properly on General Order for consideration by the full Senate.

Senator David ruled that pursuant to Section 240 of Mason's Manual of Legislative Procedure, the Presiding Officer is not required to decide any point of order that is not directly presented in the proceedings of the body. Seeing that **SB 1551** is not currently on the Senate Floor Agenda, the Presiding Officer is of the opinion that the Point of Order is not directly presented in the proceedings of the body and a ruling may not be required of the Presiding Officer.

However, as a courtesy to the Democrat Leader, the Chair will exercise her prerogative under Section 244 of Mason's Manual to defer the ruling to give the Presiding Officer an opportunity to look into the precedents and/or reach a decision on the gentleman's point."

An Act relating to game and fish; amending 29 O.S. 2011, Section 7-205, as amended by Section 2, Chapter 286, O.S.L. 2013 (29 O.S. Supp. 2015, Section 7-205), which relates to the capture and mutilation of protected wildlife; deleting restrictions on mutilating certain wildlife in certain manner; making it unlawful to waste edible meat of certain game wildlife in a certain manner; providing for certain exceptions; deleting restrictions on abandoning the body of certain wildlife; clarifying language; defining terms; and providing an effective date.

HB 2248 – By Murphey of the House and Sykes of the Senate.

An Act relating to public finance; amending Section 1, Chapter 254, O.S.L. 2015 (68 O.S. Supp. 2015, Section 1354.36), which relates to sales tax levy ballots; modifying certain definition; prohibiting certain interpretation; and providing an effective date.

Highway; designating the Dr. Herbert Rowland Memorial Bridge; designating the 1st Lt Robert E. Trigalet, USMC Memorial Highway; designating the Army T/Sgt. Yancy B. An Act relating to eminent domain; authorizing property owner to file request for judicial location exception in certain actions; specifying timing for filing reply; directing court to conduct hearing for alternative location; listing factors for court to consider in making a determination; providing for codification; and providing an effective date.

HB 2285 – By Murphey of the House and Dahm of the Senate.

An Act relating to poor persons; repealing 56 O.S. 2011, Section 1010.23, which relates to the Oklahoma Pharmacy Connection Council; and providing an effective date.

HB 2304 – By Kannady of the House and Loveless of the Senate.

An Act relating to property; amending 60 O.S. 2011, Section 833, which relates to the Residential Property Condition Disclosure Act; modifying information contained in property disclaimer and disclosure statements; and providing an effective date.

An Act relating to civil procedure; amending Section 2, Chapter 12, 1st Extraordinary Session, O.S.L. 2013 (12 O.S. Supp. 2015, Section 19.1), which relates to affidavits of merit; requiring affidavits of merit in negligence counterclaims and cross-claims; describing contents of affidavit; authorizing time extension to file affidavit; directing claimant to provide opposing party with specified information; providing exemption for indigent claimant; updating citation; and providing an effective date.

HB 2358 – By Watson of the House and Holt of the Senate.

An Act relating to cities and towns; amending 11 O.S. 2011, Sections 22-107.1 and 22-107.2, which relate to licenses or permits for the operation of cable television systems; changing scope of municipal authority from cable television services to video services; deleting certain authorization; making a certificate, license, permit or franchise a bargained contract; providing for a rental payment; limiting amount of rental payment; adding the term franchise; deleting authorization to assign or transfer a certificate, license or permit; allowing a municipality to grant overlapping certificates, licenses, permits or franchises; granting existing holders of a certificate, license, permit or franchise right to adopt certain terms; authorizing a municipality to adopt certain ordinances under certain power; expanding certain limitation; clarifying language; adding a definition; changing authorization to charge a late fee from cable television services to video services; and declaring an emergency.

An Act relating to public health and safety; amending 63 O.S. 2011, Section 1-508, which relates to animal quarantine; requiring rabies vaccination; providing exemption; and providing an effective date.

HB 2397 – By Dunlap and Sherrer of the House and Sykes of the Senate.

An Act relating to criminal procedure; amending 22 O.S. 2011, Sections 18, as last amended by Section 2, Chapter 397, O.S.L. 2015 and 19, as amended by Section 1, Chapter 178, O.S.L. 2015 (22 O.S. Supp. 2015, Sections 18 and 19), which relate to criminal arrest record expungement qualifications and procedures; adding and modifying expungement categories; deleting and replacing certain designation; and providing an effective date.

HB 2449 – By O'Donnell, Sherrer and Hoskin of the House and Barrington of the Senate.

An Act relating to motor vehicles; requiring certain traffic maneuvering and caution when approaching certain vehicles; amending 47 O.S. 2011, Section 12-227, which relates to restrictions on certain lights on motor vehicles; providing additional exception for flashing lights; providing for codification; and providing an effective date.

HB 2450 – By Leewright, Hoskin, Montgomery and Roberts (Dustin) of the House and Bingman of the Senate.

An Act relating to soldiers and sailors; amending 72 O.S. 2011, Section 6-1, which relates to impersonating members and veterans of the Armed Forces; increasing fine; and providing an effective date.

HB 2473 – By Walker, Sherrer, Hoskin and Faught of the House and Stanislawski of the Senate.

An Act relating to compulsory liability insurance; amending 47 O.S. 2011, Section 7-600.2, which relates to the online verification system; removing requirement to issue citation if no security form is produced; modifying requirement to issue citations; requiring law enforcement officer to access the online verification system if no security verification form is produced; prohibiting issuance of citation if security is established; requiring issuance of citation under certain circumstances; amending 47 O.S. 2011, Section 7-606, as last amended by Section 10, Chapter 54, O.S.L. 2015 (47 O.S. Supp. 2015, Section 7-606), which relates to penalties for failure to maintain and provide proof of insurance or security; removing certain unlawful acts; providing that if an officer obtains certain online verification there shall be no violation of the Compulsory Insurance Law; amending 47 O.S. 2011, Section 7-601.1, which relates to security verification forms; authorizing approval of security verification forms in electronic and paper format; providing an effective date.

An Act relating to motor vehicles; amending 47 O.S. 2011, Section 6-206, which relates to cancellation, suspension and revocation of driver licenses; permitting certain order by the courts; and providing an effective date.

HB 2482 – By Ownbey, Griffith, Moore, Montgomery, Caldwell, Shelton, Sanders, McDaniel (Randy), Wright, Echols, Roberts (Dustin), Munson and Murdock of the House and Simpson of the Senate.

An Act relating to professions and occupations; amending 59 O.S. 2011, Sections 567.7, 567.8, as amended by Section 3, Chapter 228, O.S.L. 2013, 567.12 and 567.17 (59 O.S. Supp. 2015, Section 567.8), which relate to the Oklahoma Nursing Practice Act; establishing certain fees for multistate license; granting power to deny, revoke or suspend multistate privilege to practice nursing; removing certain provisions related to nursing education programs for practical nurses; requiring Executive Director to suspend license of certain licensee upon default from peer assistance program; requiring certain licensee to be disciplined; setting forth terms of Nurse Licensure Compact; providing that nurses practicing under license of state that is a party to compact have same rights and obligations as holder of Oklahoma license; requiring Oklahoma Board of Nursing to take certain action against certain individuals; requiring Board to provide certain information to certain individuals; permitting Board to disclose certain information; permitting Board to receive certain grant funding; providing for codification; and providing an effective date.

An Act relating to children; amending 10A O.S. 2011, Section 1-4-502, which relates to termination of parental rights; waiving right to jury trial if party fails to appear in person after notice and without good cause; requiring nonjury trial; providing exception; and providing an effective date.

HB 2492 – By Banz of the House and Fry of the Senate.

An Act relating to motor vehicles; amending 47 O.S. 2011, Section 1135.1, which relates to specialty license plates; authorizing Civil Air Patrol vehicles for nonprofit permanent license plates; providing qualification criteria; limiting vehicle uses; providing limitation to permanency upon transfer of vehicle; exempting from certain fees; establishing fee; and providing an effective date.

HB 2519 – By Grau of the House and Stanislawski of the Senate.

An Act relating to county roads; amending 69 O.S. 2011, Section 1503, which relates to county highway funds; authorizing certain expenditures to be used for the removal and disposal of storm debris and dead animal carcasses; and providing an effective date.

HB 2523 – By Casey of the House and Griffin of the Senate.

An Act relating to municipalities; amending 11 O.S. 2011, Section 22-116, which relates to jurisdiction over real property and navigable streams; removing population requirement for jurisdiction; authorizing municipalities to enter into cooperative agreements under certain circumstances; and providing an effective date.

HB 2622 – By Osborn and Scott of the House and Justice of the Senate.

An Act relating to alternative fuels; amending 74 O.S. 2011, Sections 130.14, as renumbered by Section 18, Chapter 328, O.S.L. 2014 and as last amended by Section 2, Chapter 181, O.S.L. 2015, 130.16, as renumbered by Section 20, Chapter 328, O.S.L. 2014 and as last amended by Section 4, Chapter 181, O.S.L. 2015 and 130.17, as renumbered by

Section 21, Chapter 328, O.S.L. 2014 and as last amended by Section 5, Chapter 181, O.S.L. 2015 (40 O.S. Supp. 2015, Sections 142.6, 142.8 and 142.9), which relate to the Alternative Fuels Technician Certification Act; changing selection criteria for certain member of the Committee of Alternative Fuels Technician Examiners; modifying duties of certain officer to the Committee; authorizing the Department of Labor to issue an alternative fuels compression trainee certificate; limiting employment of a trainee; requiring trainee to work under the direct supervision of a certain technician; limiting the number of trainees working with a technician or on a job site; allowing a trainee to engage in certain licensed categories under certain conditions; adding fee for certain certificate and certificate renewal; modifying fee for annual renewal of certain certification; and declaring an emergency.

HB 2703 – By Hall of the House and Holt of the Senate.

An Act relating to public health and safety; amending 63 O.S. 2011, Section 1-323, as amended by Section 1, Chapter 211, O.S.L. 2014 (63 O.S. Supp. 2015, Section 1-323), which relates to vital statistics records; requiring State Registrar to review and authorize certain applicant requesting certain information; requiring certain fee and permitting additional fees; requiring State Department of Health to make certain index available on its website; and providing an effective date.

HB 2760 – By Kirby and Hoskin of the House and Griffin of the Senate.

An Act relating to schools; amending 70 O.S. 2011, Section 24-155, which relates to concussion information for youth athletes; defining certain terms; requiring State Department of Health to create concussion management section on its website; requiring certain information to be disseminated and acknowledgement to be completed by athlete and parent; requiring certain training by certain individuals; requiring certain individuals to remove athlete from event under certain circumstances; preventing athlete from participating in event until the athlete is permitted to return by health care provider; requiring governing boards to establish minimum penalties; requiring Department to promulgate certain rules; and providing an effective date.

HB 2775 – By McCall of the House and Smalley of the Senate.

An Act relating to revenue and taxation; amending 68 O.S. 2011, Sections 217, as amended by Section 1, Chapter 274, O.S.L. 2014, 2368 and 2385.3, as last amended by Section 3, Chapter 273, O.S.L. 2014 (68 O.S. Supp. 2015, Sections 217 and 2385.3), which relate to income taxation; modifying time period related to refunds of income tax; modifying period of time related to filing of electronic returns; modifying provisions related to individual income tax returns for fiscal years; modifying due dates with respect to certain income tax returns of business entities; modifying due dates with respect to estates and trusts; requiring reconciliation reports with respect to withholding taxes; providing an effective date; and declaring an emergency.

HB 2776 – By McCall of the House and Smalley of the Senate.

An Act relating to revenue and taxation; repealing 68 O.S. 2011, Sections 50005, 50006, 50007, 50008 and 50009, which relate to the Supernumerary Tax Consultant; and providing an effective date.

HB 2777 – By McCall of the House and Brecheen of the Senate.

An Act relating to game and fish; amending 29 O.S. 2011, Section 3-310, as amended by Section 118, Chapter 304, O.S.L. 2012 (29 O.S. Supp. 2015, Section 3-310), which relates to the Wildlife Diversity Fund; reauthorizing income tax checkoff; and providing an effective date.

HB 2797 – By Coody (Ann), Billy, Peterson, Strohm, Kern, Bennett, Christian, Ritze and Moore of the House and Griffin of the Senate.

An Act relating to schools; creating the Humanity of the Unborn Child Act; affirming public policy of the state; creating certain revolving fund; requiring funds to be expended by State Board of Education for certain purpose; requiring State Department of Education to operate certain program to educate public and students in certain grades; requiring Department to develop certain programs that contain certain criteria; prohibiting certain financings; requiring public schools operating at grade nine or ten to provide certain instruction; requiring public schools to inform parent prior to presentation of certain instruction; permitting schools which have certain program to contract with Oklahoma Department of Career and Technology Education to provide certain information and services; providing for codification; providing for noncodification; and providing an effective date.

HB 2965 – By Nelson of the House and Griffin of the Senate.
