HB 1526 – By Nollan and Lockhart of the House and Standridge of the Senate.

An Act relating to professions and occupations; creating the Seniors Prescription Safety Act of 2016; amending Section 14, Chapter 230, O.S.L. 2015 (59 O.S. Supp. 2015, Section 353.20.1), which relates to prescriptions; requiring practitioner to provide certain notice to patient; providing for noncodification; and providing an effective date.

HB 1951 – By Watson of the House and Griffin of the Senate.

An Act relating to public health and safety; amending 63 O.S. 2011, Sections 142.3 and 142.6, which relate to the Underground Facilities Damage Prevention Act; deleting exception for municipalities; requiring municipalities to participate in the statewide one-call notification center; deleting certain notification options for municipally owned facilities; updating statutory language; repealing 63 O.S. 2011, Section 142.12, which relates to duties of a municipality not participating in the statewide one-call notification center; and providing an effective date.

HB 2249 – By Renegar, Shoemake, Hoskin and Sherrer of the House and Dossett of the Senate.

An Act relating to motor vehicles; amending 47 O.S. 2011, Section 11-1302, which relates to maintenance and construction zones; updating language; making certain acts unlawful; providing penalties; and declaring an emergency.

HB 2259 – By Hoskin and Sherrer of the House and Sparks of the Senate.

An Act relating to criminal procedure; amending 22 O.S. 2011, Section 1161, which relates to acts of insane persons; updating language; defining term; authorizing videoconferencing; and declaring an emergency.

HB 2352 – By Russ of the House and Mazzei of the Senate.

An Act relating to securities; amending 71 O.S. 2011, Sections 1-302 and 1-401, which relate to the Oklahoma Uniform Securities Act of 2004; updating statutory citations; modifying notice filing procedure to comply with federal law; adding notice filing for specified federal covered security; exempting registration for person exempted by rule or order; and providing an effective date.

HB 2378 – By Vaughan of the House and Simpson of the Senate.

An Act relating to park model recreational vehicles; amending 47 O.S. 2011, Section 1102, as last amended by Section 1, Chapter 229, O.S.L. 2014 (47 O.S. Supp. 2015, Section 1102), which relates to Oklahoma Vehicle License and Registration Act definitions; adding definition for park model recreational vehicle; modifying definitions; amending 68 O.S. 2011, Section 2101, which relates to vehicle excise tax definitions; modifying definition; and providing an effective date.

HB 2380 – By Goodwin of the House and David of the Senate.

An Act relating to civil procedure; amending 12 O.S. 2011, Section 759, which relates to appraisal of property; prohibiting persons within certain degree of relation to the sheriff and sheriff's office employees from appraising certain property; requiring certain appraisals be performed by certified appraisers in certain counties; defining term; amending 59 O.S. 2011, Sections 858-701 and 858-702, which relate to the Oklahoma Certified Real Estate Appraisers Act; deleting legislative intent statement; providing applicability to certain transactions requiring appraisals; and providing an effective date.

HB 2399 – By Biggs and Jordan of the House and Sykes of the Senate.

An Act relating to criminal procedure; creating the Alyssa D. Wiles Act; amending 22 O.S. 2011, Sections 40, 40.2 and 40.3, as amended by Sections 2, 3 and 4, Chapter 206, O.S.L. 2015 (22 O.S. Supp. 2015, Sections 40, 40.2 and 40.3), which relate to victim protection orders; adding definition; authorizing immediate family members to seek victim protection orders against certain persons; authorizing immediate family members to seek emergency temporary orders of protection; providing procedure; amending 22 O.S. 2011, Section 60.3, which relates to the Protection from Domestic Abuse Act; providing jurisdictional requirement for emergency ex parte orders under certain circumstances; providing for noncodification; and providing an effective date.

HB 2431 – By Kern of the House and Standridge of the Senate.

An Act relating to children; amending 10A O.S. 2011, Section 1-4-709, which relates to permanent guardianships for deprived child; prohibiting guardianship if prospective guardian is not eligible for foster or adoptive placement; and declaring an emergency.

HB 2443 – By ODonnell, Sherrer and Hoskin of the House and Shaw of the Senate.

An Act relating to criminal procedure; amending 22 O.S. 2011, Section 982a, as last amended by Section 1, Chapter 127, O.S.L. 2015 (22 O.S. Supp. 2015, Section 982a), which relates to judicial review of sentences; increasing time limitation for sentence modification; and providing an effective date.

HB 2491 – By Coody (Ann) of the House and Fields of the Senate.

An Act relating to children; amending 10A O.S. 2011, Sections 1-2-102, as last amended by Section 1, Chapter 363, O.S.L. 2014, 1-2-105, as amended by Section 2, Chapter 355, O.S.L. 2014, and 1-6-103, as last amended by Section 4, Chapter 355, O.S.L. 2014 (10A O.S. Supp. 2015, Sections 1-2-102, 1-2-105 and 1-6-103), which relate to the Oklahoma Children's Code; directing Department of Human Services to notify military authorities of certain child abuse and neglect reports; requiring investigation include inquiry about active duty military status; providing for collection and reporting of information to military authorities; authorizing disclosure of records to military authorities without a court order; and providing an effective date.

HB 2526 – By Casey of the House and Stanislawski of the Senate.

An Act relating to revenue and taxation; amending 68 O.S. 2011, Section 2862, which relates to the county board of equalization; modifying requirements related to training; providing for forfeiture of office based on failure to meet requirements; and providing an effective date.

HB 2595 – By Morrissette, Bennett and Sherrer of the House and Simpson of the Senate.

An Act relating to criminal procedure; granting courts authority to consider posttraumatic stress disorder as mitigating factor when sentencing veterans; directing defendants to provide certain evidence; defining term; providing for codification; and providing an effective date.

HB 2623 – By Osborn of the House and Justice of the Senate.

An Act relating to revenue and taxation; amending 68 O.S. 2011, Section 1004, as last amended by Section 3, Chapter 346, O.S.L. 2014 (68 O.S. Supp. 2015, Section 1004), which relates to gross production tax; modifying termination dates for certain funding allocations; and declaring an emergency.

HB 2665 – By Cox and Murphey of the House and Crain of the Senate.

An Act relating to poor persons; requiring Oklahoma Health Care Authority to promulgate certain rules; requiring Oklahoma Department of Human Services to eliminate Medicaid eligibility for certain individuals; requiring Authority to seek certain federal approval; providing for codification; and providing an effective date.

HB 2675 – By Williams of the House and Halligan of the Senate.

An Act relating to intoxicating liquors; amending 37 O.S. 2011, Section 163.26, which relates to low-point beer; preventing certain interpretation; amending 37 O.S. 2011, Section 506, as last amended by Section 1, Chapter 275, O.S.L. 2015 (37 O.S. Supp. 2015, Section 506), which relates to Oklahoma Alcoholic Beverage Control Act definitions; modifying definitions; amending 37 O.S. 2011, Section 520A, which relates to personal use permits; authorizing certain activities; defining term; prohibiting certain acts; prohibiting certain owners and employees from certain definitions; repealing 63 O.S. 2011, Section 3001, which relates to pull-top can sales; and providing an effective date.

HB 2691 – By Brumbaugh of the House and Mazzei of the Senate.

An Act relating to revenue and taxation; amending 68 O.S. 2011, Section 217, as amended by Section 1, Chapter 274, O.S.L. 2014 (68 O.S. Supp. 2015, Section 217), which relates to computation of interest on delinquent tax liabilities; providing for modification of interest rate based on New York Federal Reserve Bank prime rate; and providing an effective date.

HB 2704 – By Hall and Roberts (Sean) of the House and Brooks of the Senate.

An Act relating to state government; amending 74 O.S. 2011, Section 500.4, which relates to the State Travel Reimbursement Act; modifying reimbursement for state travel; and providing an effective date.

HB 2764 – By Montgomery of the House and Ford of the Senate.

An Act relating to education; creating the Oklahoma Education Finance Authority; providing for appointments to the board of trustees; prescribing terms of office; providing for applicability of Oklahoma Open Meeting Act; providing for applicability of Oklahoma Open Records Act; providing exception; authorizing adoption of administrative rules; providing for applicability of Administrative Procedures Act; imposing quorum requirement; authorizing meetings; prescribing minimum number of meetings; authorizing executive director or chief administrative officer; specifying powers and duties with regard to employees; imposing time limit for certain recognition of exempt status; providing for receipt of contributions; requiring investment of principal according to certain standard; providing for expenditure of earnings; authorizing certain expenditure of principal for certain expenses; limiting expenditure of principal based on fiscal year designations; requiring website; prescribing requirements for certain information to be accessible through website; creating the Oklahoma Education Finance Authority Endowment Fund; providing for sources of income; providing for expenditures; prescribing procedures for expenditures; providing for income tax checkoff for the Oklahoma Education Finance Authority Endowment Fund; prescribing procedures for individuals and corporations; providing for codification; and providing an effective date.

HB 2816 – By Walker and Ritze of the House and Dahm of the Senate.

An Act relating to state government; prohibiting certain officials from using certain public service announcements and advertisements; providing exceptions; providing for codification; and providing an effective date.

HB 2822 – By Denney of the House and Halligan of the Senate.

An Act relating to schools; amending 70 O.S. 2011, Section 6-122.3, as last amended by Section 7, Chapter 124, O.S.L. 2014 (70 O.S. Supp. 2015, Section 6-122.3), which relates to eligibility for an alternative placement teaching certificate; changing the number of hours for the professional component; modifying certain criteria for granting an alternative placement teaching certificate; allowing certain rating to be considered; updating references to the Commission for Teacher Preparation; providing an effective date; and declaring an emergency.

HB 2834 – By Echols and Bennett of the House and Dahm of the Senate.

An Act relating to firearms; amending 21 O.S. 2011, Sections 1289.16, as amended by Section 20, Chapter 259, O.S.L. 2012 and 1289.25 (21 O.S. Supp. 2015, Section 1289.16), which relate to the Oklahoma Firearms Act of 1971; clarifying scope of certain prohibited act; deeming specific act lawful under certain circumstances; adding definition; and providing an effective date.

HB 2934 – By McCullough of the House and Sykes of the Senate.

An Act relating to criminal procedure; amending 22 O.S. 2011, Section 815, which relates to the dismissal of an action or indictment; authorizing the dismissal of prosecutions by district attorneys; providing for payment of costs upon agreement; and providing an effective date.

HB 2937 – By McCullough, O'Donnell, Cleveland and Russ of the House and David of the Senate.

An Act relating to drug courts; authorizing Department of Mental Health and Substance Abuse Services to implement a voluntary pilot program for certain drug court participants; providing for the use of certain approved drugs for medication-assisted treatment; authorizing the Department to select participants; providing that refusal to participate in the pilot program shall not be grounds for termination from the drug court program; providing certain eligibility requirements; allowing for the use of approved treatment providers to administer medication-assisted treatment; stating requirements for treatment providers; defining term; providing for the promulgation of rules and procedures; providing for codification; and providing an effective date.

HB 2943 – By Henke and Sherrer of the House and Smalley of the Senate.

An Act relating to banks and trust companies; amending 6 O.S. 2011, Sections 1301.2 and 1308, which relate to safe deposit boxes; deleting time limitation for safe deposit box access after death; deleting reference to repealed statute; directing financial institution to release contents to affiant; authorizing affiant to terminate lease and close box; excluding liability for release of box contents; removing reference to repealed statute; and providing an effective date.

HB 2997 – By Moore of the House and Simpson of the Senate.

An Act relating to state government; authorizing agencies to establish education and training programs; authorizing certain contracts; providing for funding of programs; clarifying employee status; establishing criteria for participation in program; authorizing tuition reimbursement for successful candidates; outlining procedures for promissory note; establishing penalties; authorizing payment of certain fees; directing promulgation of rules; providing for codification; and providing an effective date.

HB 3105 – By Caldwell of the House and Yen of the Senate.

An Act relating to professions and occupations; amending 59 O.S. 2011, Sections 1352.1, 1353, 1360, 1362, 1366, 1369, 1370, as amended by Section 8, Chapter 183, O.S.L. 2015 and 1375 (59 O.S. Supp. 2015, Section 1370), which relate to the Psychologists Licensing Act; authorizing State Board of Examiners of Psychologists to establish certain fees; providing that expenditures from certain fund be made by warrants issued by State Treasurer; requiring applicant for licensure to graduate from certain doctoral programs after certain year; requiring applicant to pay for certain costs; requiring Board to publish list of licensed psychologists on website; permitting Board to impose certain administrative fine; permitting Board to keep investigative file confidential; requiring psychologists to report certain information to the Board; providing for immunity; permitting Board to defer certain disciplinary action and psychologist to enter into certain agreement; providing for codification; and providing an effective date.

HB 3109 – By Caldwell of the House and Stanislawski of the Senate.

An Act relating to schools; amending 70 O.S. 2011, Section 6-101.6, which relates to categories of employment contracts; requiring school districts to annually present a copy of employee information worksheets to teachers and administrators prior to a certain time; requiring school districts to designate a person to review worksheets and answer questions; directing that a signed acknowledgement form be placed in the employee record; providing an effective date; and declaring an emergency.

HB 3119 – By Martin of the House and Shaw of the Senate.

An Act relating to criminal procedure; amending 22 O.S. 2011, Sections 471.6 and 471.9, which relate to the Oklahoma Drug Court Act; authorizing the reduction or waiver of court costs, fees and fines under certain circumstances; and providing an effective date.

HB 3130 – By Cockroft of the House and Griffin of the Senate.

An Act relating to counties; amending 19 O.S. 2011, Section 1501, as last amended by Section 1, Chapter 226, O.S.L. 2014 (19 O.S. Supp. 2015, Section 1501), which relates to county purchasing agents; increasing dollar amount of purchases that are exempt from certain bidding procedures; and providing an effective date.

SB 923 by Simpson of the Senate and Roberts (Dustin) of the House was called up for consideration.

Senator Simpson moved to amend **SB 923**, Page 2, Line 11½, by restoring the title and inserting Subsection D to read as follows:

“D. The Oklahoma Military Department shall annually report to the President Pro Tempore of the state Senate, the Speaker of the House of Representatives, and the Secretary of Finance the amount of savings realized from its authority to purchase motor vehicles. If such report is not filed or does not document such savings, the authority of the Department to purchase motor vehicles shall cease to be in effect on January 1, 2022.”; and, by relettering subsequent subsections, and adding new Sections 2 and 3 to read as follows:

“SECTION 2. It being immediately necessary for the preservation of the public peace, health and safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.

SECTION 3. This act shall become effective July 1, 2016.”, which amendment was declared adopted.

Senator Simpson moved that **SB 923** be advanced, which motion was declared adopted.

Senator Simpson requested **SB 923** be laid over temporarily, which was the order.

SB 923 remains on Third Reading.
