ENROLLED SENATE BILL 799

This is ripe for abuse. It gives bad actors wide breadth to take advantage of vulnerable youths and adolescents. This bill lets schools replace parents with “alternate adults” when the parent doesn’t object to a mailed letter fast enough. That’s not due process, that’s displacement.

The bill defines these alternates broadly, including case managers or employees from shelters or agencies, giving them authority meant for parents. It doesn’t go far enough in ensuring that effort is made to find student’s parents or guardians. It’s an erosion of parental rights. Helping vulnerable and homeless students is important, but sidelining families is not the answer.

For these reasons, I have vetoed Enrolled Senate Bill 799.

ENROLLED SENATE BILL 915

Pursuant to the authority vested in me by Section 11 of Article VI of the Oklahoma Constitution, I have vetoed Enrolled Senate Bill 915.

The Commissioners of the Land Office (CLO) exists for one purpose: to generate maximum returns from state-owned lands for the benefit of public education. This bill imposes unnecessary restrictions that hinder the CLO's ability to fulfill that mission. Notably, this bill doesn't place the same restrictions on other lands. If this is good policy it should apply to everyone equally and not single out state owned land.

To serve our schools effectively, the CLO must retain the flexibility to manage its assets in the most profitable and efficient manner. Every dollar lost to bureaucratic constraint is a dollar not reaching our classrooms.

For these reasons, I have vetoed Enrolled Senate Bill 915.
