Agency Mission

The mission of the office of the Attorney General is to seek justice for the people of Oklahoma by upholding the rule of law; serving public safety through prosecutions and civil enforcement actions; providing high-quality legal representation for the state agencies; and protecting and defending the Oklahoma and U.S. constitutions.

Division and Program Descriptions

1000001-Administration

Administration is primarily responsible for agency management and direction. Administration is responsible for setting the agency mission and goals and performance measures needed to obtain that mission. Administration also houses the centralized functions of the agency essential to all other units and sections. This program also establishes the direction the agency will go in reaching out to the citizens of Oklahoma. Administration plans on continuing the identification and implementation of new legal solutions to persistent problems and looking for innovative ways to maintain employee morale and work product.

1500001-Office of Solicitor General

The Office of Solicitor General represents the State in defense of the constitutionality of State laws and in appeals on these and other issues of public importance at the highest level (including the Oklahoma and United States Supreme Courts). The Solicitor General also plays a key role in representing the State on the national stage, engaging in interactions with and litigation against the federal government and other States. The Reserved Powers Protection Unit, under the direction of the Solicitor General, monitors and evaluates any action by the federal government including, but not limited to, executive orders by the President of the United States, rules or regulations promulgated by an agency of the federal government or acts of Congress to determine if such actions are in violation of the Tenth Amendment to the Constitution of the United States.

2500002-Criminal Appeals

The primary purpose of the Criminal Appeals Unit is to preserve just convictions of the guilty and to ensure the punishments rendered by trial courts and/or juries are carried out. Criminal Appeals accomplishes this purpose by filing quality briefs and/or responses in the courts, providing oral arguments of the highest caliber to claims seeking reversal of convictions in state and federal courts, and representing the State in evidentiary hearings in remanded cases. In recent years, on an annual basis, Criminal Appeals typically files more than 400 briefs across state and federal courts and oversees 3 to 4 executions of capital defendants. Prior to an execution, Criminal Appeals represents the State in all stages of capital litigation, during all ordinary appeals in the state and federal appellate courts, before the Pardon and Parole Board for clemency proceedings, and in any eleventh-hour litigation preceding the execution. Criminal Appeals provides research and drafting support to District Attorney's Offices across the State as requested.

2500003-Consumer Protection

Through its Consumer Protection Unit (CPU), the Oklahoma Attorney General is committed to combating consumer scams, fraud, and unlawful business practices. To achieve this goal, the Consumer Protection Unit assists consumers by conducting community outreach and education programs; intaking and investigating consumer complaints; prosecuting those who violate Oklahoma's consumer laws; and filing enforcement actions against persons engaged in illegal, deceptive, fraudulent, or unfair advertising or sales practices and persons who commit actions or conspire to commit actions that restrain or monopolize trade or commerce. Throughout the year, CPU's attorneys, agents, and staff participate in community events to educate Oklahomans on subjects ranging from government imposter scams and cyber threats to avoiding fraud in the wake of weather-related disasters. CPU manages thousands of consumer complaints, and as a result, tens of thousands of dollars are returned to consumers every year. CPU is responsible for the enforcement of numerous state and federal laws that protect consumers against deceptive, unfair and fraudulent business practices. In addition, CPU is charged with enforcing various laws that regulate charitable giving within the state. Through these laws, the unit ensures that charitable organizations are engaging in proper solicitations, the intent of charitable donors is honored by reviewing and enforcing restrictions on charitable gifts and trusts, and charitable organizations properly dissolve, merge, change purposes, and distribute assets when such distributions constitute all or substantially all of the organizations' assets.

2500004-Conservation Unit

The Conservation Unit protects the people and the environment of Oklahoma by providing legal counsel and guidance to state offices and agencies and by bringing litigation on behalf of the state. The Conservation Unit serves as general counsel to the Environmental Quality Board and provides legal assistance to the Secretary of Energy and Environment, who is the state's natural resources trustee.

2500005-Utility Regulation

The purpose of the Utility Regulation Unit is to carry out the Oklahoma Attorney General's duty "[t]o represent and protect the collective interests of all utility consumers of this state in rate-related proceedings before the Corporation Commission or in any other state or federal judicial or administrative proceeding." The Utility Regulation Unit seeks to accomplish this purpose by fully and consistently advancing positions on utility customers' behalf in state and federal proceedings. To this end, the Utility Regulation Unit also monitors legal and regulatory developments, participates in rulemakings, and participates in legislative and working group initiatives related to Oklahoma public utilities.

2500006-Litigation

The primary purpose of the Litigation Unit is to defend the State, its agencies, officers and employees in lawsuits filed against them in all state and federal courts. With regard to officers and employees, the Litigation Unit defends individuals who have been sued for performing acts in the course and scope of their employment, which includes lawsuits ranging from a car accident to a class action. The Litigation Unit aspires to provide quality legal representation to all of our clients and to assist our clients in determining how to best respond to lawsuits.

Legal Counsel assists 136 state officials, agencies, boards, and commissions by providing objective, responsive legal counsel, using comprehensive and specialized expertise. In addition, Legal Counsel reviews all bond issues on behalf of the Oklahoma Attorney General, as an Ex Officio Bond Commissioner for the State of Oklahoma, to ensure they are in compliance with the Constitution and the laws of the State of Oklahoma.

2500008-Pharmacy Benefits Manager

The Pharmacy Benefit Manager Unit is responsible for ensuring compliance of pharmacy benefit managers (PBMs) with the Patient's Right to Pharmacy Choice Act and the Pharmacy Audit Integrity Act. The unit primarily executes its mission by initiating enforcement actions after receiving complaints from impacted pharmacies and review of required data reports from licensed PBMs. Enforcement actions may result in financial penalties or loss of a PBM's license.

2500009-Tobacco Enforcement

As part of the Master Settlement Agreement, Oklahoma was required to enact a Qualifying Statute, the purpose of which included effectively and fully neutralizing the cost disadvantages the Participating Manufacturers experience vis-a-vis Non-Participating Manufacturers who have not joined the Master Settlement Agreement. In essence, manufacturers that did not join the Master Settlement Agreement were required to deposit money into an escrow account for each cigarette sold in Oklahoma in an amount equivalent to what they would have paid if they had joined the Master Settlement Agreement. If, during a calendar year, a Qualifying Statute failed to be in full force and effect or to diligently enforce its Qualifying Statute, the State could lose its entire Master Settlement Agreement payment for that year. Thus, the Qualifying Statute requires Oklahoma to identify the non-participating manufacturers selling in Oklahoma and the number of non-participating manufacturers' cigarettes sold in the State. In addition, the Escrow Statute requires the Oklahoma Attorney General file court complaints seeking compliance from those non-participating manufacturers that failed to fund or fully fund an escrow account. Complementary legislation that increased remedies available against non-conforming non-participating manufacturers and eliminated the allocable share release provision was enacted in Oklahoma in 2004 and became effective in January 2005. Statutory changes were made to the Complementary Act to protect Oklahoma's future Master Settlement Agreement payments and increase staffing of the Tobacco Enforcement Unit. All tobacco product wholesalers and a substantial number of retailers located in Oklahoma are audited and inspected annually.

2500010-Civil Rights Enforcement

The Office of Civil Rights Enforcement serves Oklahoma citizens by educating and providing educational resources to the public regarding anti-discrimination rights and responsibilities; enforcing the Oklahoma Anti-Discrimination Act, which prohibits discrimination in employment, housing, and public accommodation, and other civil rights related laws; investigating citizen complaints of discrimination when jurisdictional; and partnering with the public to positively and proactively advance the cause of civil rights for the equal benefit and enjoyment of all Oklahomans.

2500011-Human Trafficking

HB 4210 (2022) adds Human Trafficking to the duties of the Attorney General requiring the Attorney General to maintain data relating to human trafficking and to assist law enforcement, social service agencies, and victim services programs in identifying and supporting victims of human trafficking. The Unit is also required to provide training on best practices, provide support to agencies, provide targeted funding for victim services programs and conduct a public service announcement (PSA) campaign.

2500015-Ombudsman

The State Long-Term Care Ombudsman Program serves residents in Oklahoma's long-term care facilities including nursing homes, assisted living, and residential care facilities, by helping to improve the residents' quality of life and the available quality of care. A long-term care Ombudsman receives complaints from residents of long-term care facilities or anyone who has contact with residents and attempts to resolve those complaints by communicating with the facility and others associated with complaint. The long-term care Ombudsman has authority to explore problems and make recommendations with residents' consent. The State Long-Term Care Ombudsman Program is administered by the State Ombudsman staff through their oversite and support of Area Agencies on Aging that provide contracted services to residents statewide. The State Long-Term Care Ombudsman Program is also supported by volunteers, who are supported and supervised by the Area Agencies on Aging.

2800001-Legal Aid Services

Appropriated pass through funds to provide legal representation to indigent persons in the State of Oklahoma in civil legal matters.

3000001-Criminal Justice

The Multi-County Grand Jury Unit serves as the legal advisor to the Multi-County Grand Jury; processes and assists in special prosecutions with District Attorneys and other Oklahoma Attorney General investigations; can serve as the legal advisor for County Grand Juries where the District Attorney was disqualified; investigates and acts upon Title 51 Citizen Complaints; reviews and presents wiretap applications to the Oklahoma Court of Criminal Appeals; organizes and hosts quarterly Human Trafficking Working Group for law enforcement entities state wide; represents State Medical Examiner in 22 OS 751 hearings, investigates and prosecutes internet crimes against children.

3000003-Organized Crime

The Attorney General created an Organized Crime Task Force (OCTF) to combat the scourge of illegal marijuana grow operations across Oklahoma. OCTF works closely with OBN, OMMA and other federal, state and local agencies to investigate all crimes related to illegal grow operations, including human trafficking and the distribution of deadly drugs such as fentanyl. HB 2095 (2023) gave OCTF full enforcement authority over medical marijuana laws including authority to subpoena business documents, conduct unannounced on-site inspections, seize and destroy illegal products and to enter into agreements with other state agencies to combat illegal operations. OCTF has added a resource for citizens to report suspicious activity related to suspicious operations.

Established in 2012, The Justice Reinvestment Initiative (Safe Oklahoma Grant Program) is funded by an annual appropriation from the state legislature. All local law enforcement agencies and sheriff's offices are eligible for the grant. Grants are made for a one-year period. The Safe Oklahoma Grant Program provides local law enforcement agencies and sheriff's offices with additional resources to address violent crime in the state. The money from the grant helps pay overtime costs for officers, technology upgrades, enhanced analytical capabilities and funds community partnership projects that focus on preventing youth violent crime.

3500001-Court Appointed Special Advocate

The Court Appointed Special Advocate is strictly a pass-through program via 68 O.S. § 2368.12 - Income Tax Checkoff Revolving Fund for Court Appointed Special Advocates. The entire amount is distributed to Oklahoma CASA programs.

4000001-Medicaid Fraud Control Unit

The Multi-County Grand Jury Unit serves as the legal advisor to the Multi-County Grand Jury; processes and assists in special prosecutions with District Attorneys and other Oklahoma Attorney General investigations; can serve as the legal advisor for County Grand Juries where the District Attorney was disqualified; investigates and acts upon Title 51 Citizen Complaints; reviews and presents wiretap applications to the Oklahoma Court of Criminal Appeals; organizes and hosts quarterly Human Trafficking Working Group for law enforcement entities state wide; represents State Medical Examiner in 22 OS 751 hearings, investigates and prosecutes internet crimes against children.

4500001-Worker's Compensation and Insurance Fraud

The Workers' Compensation and Insurance Fraud Unit provides the exclusive prosecution of social security and workers' compensation fraud occurring in the State of Oklahoma. In addition, the Workers' Compensation and Insurance Fraud Unit provides added prosecution of insurance fraud by prosecuting complex cases and cases that have a statewide impact.

4500003-Cooperative Disability Investigations

The Cooperative Disability Investigations Unit (CDIU) investigates individual disability beneficiaries, claimants, and identifies lawyers, doctors, translators, or other third parties who facilitate disability fraud. CDIU works with the Social Security Administration (SSA), the SSA Office of the Inspector General, and the State Disability Determination Services (DDS). Results of CDIU's investigations are presented to federal and state prosecutors for consideration of prosecution and to SSA, Office of Hearings Operations, and DDS for their use in making timely and accurate disability determinations.

5000001-Victims Services

The Victim Services Unit works to provide and improve services for crime victims across the state. The duty of the unit pursuant to 74 O.S. § 18p-1 is to provide services for persons who require domestic violence or sexual assault services through programs that offer shelter, residential services or support services to victims of domestic abuse, sexual assault stalking and those who are homeless as a result of those abuses. The Victim Services Unit oversees certification for domestic violence, sexual assault and adult human sex trafficking programs and batterer's intervention programs across the state. The Victim Services Unit contracts with the domestic violence and sexual assault programs to offer funding for their core services. The statutory authority for many of the duties can be found in 74 OS § 18p-1 through 18p-9. The Victim Services Unit also provides direct services in the form of advocacy and referral services, appellate notification and advocacy to survivors and victims' families in death penalty cases. The Unit provides for a 24-hour Safeline that can be accessed statewide by victims and family members for immediate support and service connection and referral; an Address Confidentiality Program for victims of domestic violence, sexual assault and stalking who need help preventing an abuser from locating their residence; the Victim Information and Notification Everyday (VINE) notification system to keep victims and family members updated on an offender's location and incarceration status and to notify of protective order status changes; statewide and regional training for law enforcement officers, prosecutors, victim advocates, health care professionals, and various other service providers; facilitation of the Domestic Violence Fatality Review Board and statistical database maintenance and a statewide Victim Assistance Academy to equip service providers to adequately respond to crime victims of all types.

8800001-Information Services

The Office of Attorney General contracts with OMES and NTT Data to provide, maintain, and support computers, hardware, software, software maintenance agreements, provide upgrades, telephones, and mobile electronics necessary to support agency operations. Additional information technology costs and software run through this division.

The AG's Office provides a coordinated state, local and federal response to issues plaguing Oklahoma. With a reduction in the FY27 budget, the AG's Office would likely need to curtail and even reduce planned efforts to expand the reach of the organized crime task force, investigations/prosecutions of organized retail crime, and pharmacy benefit managers at minimum.

Yes, the Medicaid Fraud Control Act, the Family Violence Prevention and Service Act, and the grant to investigate and prosecute cold cases all require a pre-determined match level.

3.) What would the consequences be of ending all of the federal funded programs for your agency?

Funding for the State domestic violence, sexual assault, human trafficking, and children's services shelters would be reduced by approximately \$1.5m.

Funding for the Attorney General's Medicaid Fraud Control Unit would be reduced by approximately 75% and would drastically reduce the recovered funds and the number of cases the Medicaid Fraud Control Unit could investigate annually.

4.) How will your agency be affected by federal budget cuts in the coming fiscal year?

There are no anticipated federal cuts impacting the AG budget, at this time.

5.) Has the agency requested any additional federal earmarks or increases?

The agency continuously looks for additional federal funding if it aligns with our mission. For example, we applied for the cold cases grant recently to allow our office to address unsolved murders, and a grant to support Lethality Assessment Protocol (LAP) training for local law enforcement.
