## **MESSAGE FROM THE GOVERNOR**

Advising his approval February 6, 2026, of Enrolled **SB 743**.

The approval message reads as follows:

February 6, 2026

TO THE HONORABLE PRESIDENT PRO TEMPORE  
AND MEMBERS OF THE OKLAHOMA SENATE  
SECOND REGULAR SESSION OF THE  
SIXTIETH OKLAHOMA LEGISLATURE

### **ENROLLED SENATE BILL NO. 743:**

I have signed enrolled Senate Bill 743 and have caused the same to be filed with the Office of the Secretary of State.

As Governor, I swore an oath to uphold the United States and Oklahoma Constitutions. The State of Oklahoma is committed to protecting the constitutional rights of citizens, including the freedom of speech, assembly, and free exercise of religion.

While I have consistently opposed creating new felonies for non-violent offenses, and I take issue with this provision in the legislation, at its core this bill protects the constitutional right of every Oklahoman to freely worship without fear of harassment or intimidation by protestors. At the same time, this bill preserves reasonable means for protestors to communicate their message in a lawful manner that does not disrupt church services or interfere with the right of others to freely worship.

With my noted concerns, I affix my signature to this legislation.
