Second Regular Session of the Sixtieth Legislature of the State of Oklahoma

Thirty-eighth Legislative Day, Thursday, April 9, 2026

The Senate was called to order by Senator Hall.

GENERAL ORDER

HJR 1024 by Moore and Harris of the House and Gollihare of the Senate was called up for consideration.

Senator Gollihare moved to amend **HJR 1024**, Page 7, Line 1 ½, by inserting a new SECTION 3 to read as follows, by renumbering subsequent section, and by amending the title to conform: “SECTION 3. A special election is hereby ordered to be held throughout the State of Oklahoma on the date of August 25, 2026, at which time the proposed amendment to the Oklahoma Constitution, as set forth in SECTION 1 of this resolution, shall be submitted to the people of Oklahoma for their approval or rejection as and in the manner provided by law.”, which amendment was declared adopted upon roll call vote as follows:

GENERAL ORDER

Senator Paxton moved that **HJR 1087** be advanced, which motion was declared adopted.
