## Second Regular Session of the Sixtieth Legislature of the State of Oklahoma

Fortieth Legislative Day, Tuesday, April 14, 2026

The Senate was called to order by Senator Haste.

**JOINT SESSION**

The Second Joint Session of the Second Regular Session of the Sixtieth Legislature was called to order by Speaker Hilbert.

Senator Howard moved that the attendance roll call of the Senate be considered the attendance roll call of the Senate in Joint Session, which motion was declared adopted.

Posting of the Colors was presented by the Cadets of the Thunderbird Challenge Program.

The invocation was offered by Oklahoma Army National Guard Chaplain, Col. Josh Byrd.

Lieutenant Governor Pinnell recognized the Adjutant General, Major General Thomas Mancino, who addressed the Joint Session.

Major General Mancino introduced Representative Derrick Hildebrant, who addressed the Joint Session.

Lieutenant Governor Pinnell recognized Lieutenant Colonel Harvey for the reading of a Proclamation from Governor Stitt recognizing Oklahoma National Guard Appreciation Day.

Upon motion of Representative West (Josh), the Second Joint Session was ordered dissolved at the hour of 10:30 a.m.
